- 1. R. Collado/ L. Velazquez of NYPL spoke on the availability of Sunday service at their respective libraries. The City Island Branch received \$2 million for capital reconstruction and to repair its HVAC system. The Westchester Square Branch has a therapy dog every Wednesday. On February 22nd the Baychester Branch is hosting an event alongside Council Member Riley as he debuts his self-authored book.
- 2. N. DiMichelle, resident, spoke about e-scooters. Often, the scooters are lying in the middle of sidewalks. Delivery persons are riding on sidewalks and that there should be more enforcement.

DISTRICT MANAGER'S REPORT: Mr. Cruz

Mr. Cruz spoke on a potential Housing and Zoning Committee to review the ULURP item for a casino and hotel at Bally's Links. The meeting will be held off-site. Mr. Cruz clarified an update regarding the Bruckner Boulevard rezoning. Site A, which is Foodtown Supermarket, will no longer undergo construction. The supermarket has changed hands in ownership. Sites B, C and D, at the moment, have not filed any building plans for construction. Mr. Cruz informed the Office of Cannabis Management that 4010 East Tremont Avenue is a near an early childhood center and that it is within 500 feet. Mr. Cruz hopes to hear from OCM by the end of January. The Westchester Square station elevator is now fully operational. Middletown Road Station will not receive an elevator.

ELECTED OFFICIALS:

Mayor's Office Community Affairs Office: Ms. Dowe announced that 19,000 guns were confiscated in the City of New York. There is unusually colder weather. Residents must contact 311 if they see someone lying on the street. A. Dowe is working with District Manager Cruz as to why certain smoke shops have re-opened.

U.S. Representative Ocasio-Cortez Office: Katerine Quinde announced that the Congress Member will serve on the Energy Committee. Ms. Quinde urged residents to check Ica.gov for status updates on immigration status.

Senator Fernandez Office: David Montilla introduced himself. Senator Fernandez remains as Chairwoman of the Senate Substance Abuse Committee. Mopeds now must register with the State Department of Motor Vehicles. There will be an unclaimed funds event in February with the State Comptroller. There will be a virtual budget town hall that will occur in February.

Senator Bailey Office: Huntley Spencer introduced himself. Senator Bailey is collecting toiletries and new clothes for the residents and victims of the fire on Wallace Avenue. Senator Bailey is now the Chairman of the Senate Committee on Insurance.

Council Member Riley Office: C. Prisco announced a free legal clinic for veterans. On January 22nd and January 26th, there will be a non-profit training for those interested in applying for New York City Council discretionary resources.

Council Member Marmorato Office: A. Cardena informed the community that CM Marmorato is actively working with city officials on the e-scooter program. There is an active Mulford Avenue water main break. CM Marmorato will hold a "coffee with the Council Member" event at Pete's Coffee Shop from 9 am to 11am this Saturday. On February 20, Con Edison representatives will be present in their district office. There is an active coat drive. All can donate their coats to the district office through the end of January. CM Marmorato is collecting Valentine's Day cards from districts students to send to our troops overseas.

Council Member Farias Office: Council Member Farias announced legislation that she has proposed such as language access along our NYC Ferry system, reimbursing nonpublic schools with security funding. CM Farias Family Nature Club is on March 2 at the Bronx Zoo. CM Farias will research the possibility of the City of New York giving senior citizens the new garbage pails for free.

OLD BUSINESS: None

NEW BUSINESS: A. Torres announced a potential February event in honor of Valentine's Day.

Motion to close the 2025 Public Hearing and Full Board meeting was unanimous.
