- 2. Bob Bieder, 45th Precinct Community Council held several events; noted future events planned for the Spring; a new captain is beginning tomorrow Captain Ortiz starting 2/21; precinct is down 30 officers.
- 3. David Abreu, Save The Sound: 80 miles of coastline in the state; read a written statement about the conditions of the waters; STS has serious concerns about the proposal of Bally's to build.
- 4. Desiree Brown, Co-op City: had questions about the Bally's and the impact on the community.
- 5. Linda DeVito, CB #10 resident: against the development of Bally's Casino and Hotel, noted health concerns/air quality, traffic issues.
- 6. Joan Gerardi, CB #10, member of Waterbury LaSalle: against Bally's Casino and Hotel quality of life concerns and transportation.
