Economic Development Committee Meeting Tuesday, May 4, 2021

The meeting began at 7:35 PM with the Pledge of Allegiance. Mr. Accomando acknowledged all in attendance and stated that we have a very extensive agenda tonight. the Committee's questions and was aware of all the concerns at that location noting that she lives in the area as well. At this time the Chairman made a motion to accept. It was made Mr. Smith and second by Mr. Popovic. The vote was unanimous.
