

R. Bieder reach the following motion. It was proposed by T. Accomando and seconded by M. Caruso. It unanimously passed.

Resolved...at the request of the Municipal Services Committee that a letter be drafted to City Council Member Marjorie Velazquez that the corner of East Tremont Avenue and Sommer Place be renamed "James McQuade Way" and that this be forwarded to the Full Board for its approval.

The Committee then heard presentations from the MTA Metro North and MTA NYC Transit regarding the proposed Co-op City Station and the three elevators slated for the Westchester Square station. Presentations of the projects are at the Board Office and will be furnished upon request. The Co-op City Station is slated to be finished by 2025. The elevators for the Westchester Square station are to be completed by 2024.

During old business Committee Members made requests for traffic controls, review of a bus stop that is to be removed at Harding Avenue and Brinsmade Avenue. M. Caruso of Gateway has written a letter to Commissioner Rodriguez regarding city property that has commercial trucks.
