The meeting began at 7:30 PM with the Pledge of Allegiance. Mr. Accomando welcomed all in attendance and read the conduct document. Mr. Accomando addressed the attendees and said when your establishment is called state your name and a position in the establishment and give a little synopsis of the establishment.

There was a discussion with the representative(s) from each establishment and the committee. It was at this time the committee elected to vote on Coconut Palm Bar & Grill separately to further discuss some incidents taking place. There was a motion to except the other renewals made by Mr. Popovic and second by Mr. Chirico. The vote was unanimous.

The committee then went on to address their concerns with the Coconut Palm Bar & Grill. The committee and the owner discussed ways of improving the operations in the establishment and their compliance to the stipulations signed. Three committee members that live close by noted that the establishment had improved since the new owner took over. With that said a motion to accept the Resolution was made by Mrs. Acampora and seconded by Mr. Popovic. The vote was unanimous. It was at this time Mr. Accomando acknowledged all the hard work and time that Mr.Caruso puts into this committee.

The committee went on to the change in method of operation for Made in Puerto Rico. The residents from Haskin St. spoke to the committee about their concerns. The owner stated he had no knowledge of their complaints and stated that he has been reaching out to CB10 and talking to Mr. Cruz, for updates. The committee also had no knowledge of any complaints from the residents made to the office. Mr.Popovic did mention that henoticed

that the area has been maintained better than before. Mr. Accomando did mention that he was supposed to install cameras on the side of the building and to have his security personnel now and then monitor the block; so far he has failed to comply. There was also a recent incident involving police that the committee need more clarification and is obtaining that information at this time. There was a motion to accept the Resolution made by Mr. Bieder and seconded by Mr. Popovic. The vote was unanimously against, therefore it did not pass.
