

Economic Development Committee September 1, 2020, 7:30 PM Cisco Webex

The meeting began at 7:30 with the Pledge of Allegiance. Mr. Accomando thanked all attendees for participating in the Webex meeting and expressed concern that this is a very difficult time for the restaurant establishments. Mr. Accomando then stated when their establishment is called on please tell us how you have been managing during the coronavirus crisis. The establishments expressed concerns on how to survive during this virus. The Chair informed them that he was planning a rally to allow for indoor dining at 50% capacity. They were very interested and said they would attend the rally. After addressing issues with some locations on social distancing the committee went on to liquor licenses. At this time the chair called for a motion to except the renewal licenses. It was made by Mr. Popovic and second by Mr. Smith. The vote was unanimous.

*Man Overboard, 247 City Island Ave, between Carroll & Schofield Streets, License #1300496, which expires on 09/30/2020.

*Yamada, 3811 E Tremont Ave, 10465, between Randall & Schley Avenues, License # 1280430, which expires on 09/30/2020.

*Jimmy Ryan's, 3003-3007 Middletown Road, between Crosby Avenue & Hobart Aves, License #1003968, which expires on 11/30/2020.

The committee went on to address new licensees. There was only one new licensee who had to reapply at this time due to time constrictions. And they had previously passed the committee and full board as well. So the Chair called for motion to accept the new license. It was made by Mr. Popovic and second by Mr Smith.
