

ECONOMIC DEVELOPMENT COMMITTEE MEETING MINUTES OCTOBER 6, 2020, 7:30 P.M. Cisco Webex

Meeting began at 7:30 p.m. with Pledge of Allegiance. Mr. Accomando thanked all in attendance for participating in the Webex meeting and expressed his concerns that this is a very difficult time for the restaurant establishments. Mr. Accomando asked that when an establishment is called upon to include informing the committee as to how the establishment is managing during the coronavirus crisis and added that the 25% indoor dining should help. Establishments shared their concerns on how they were coping with this crisis and the added expenses incurred in order to do business, especially the renewal liquor license costs at full price, considering the months long closures during the pandemic. The Chair informed them that he would address the concerns and see if he could get some relief with their expenditures going forward. He also went on to discuss that fine issues to PARQ from the SLA and the guidelines imposed on the establishment. He also expressed concern for them to do better. A motion to accept the renewal licenses was made by Mr. Popovic and seconded by Ms. Chambers, with a unanimous vote.

The committee addressed the new licensees, of which there were three, one of which was previously submitted in February 2020 and approved in committee and the full board. A motion to accept the new licenses was made by Mr. Smith, seconded by Mr. Bieder, with a unanimous vote.
