

The meeting began at 7:35 with the Pledge of Allegiance. Mr. Accomando thanked all in attendance for participating in the WebEx meeting and expressed his concern that this is a very difficult time for the restaurant establishments.

The committee then went on to address the Renewals. Mr. Accomando stated when your establishment is called on please tell us how you've been managing during the coronavirus crisis. Some establishments expressed many concerns of the unknown future for the business and coping as best they could under the cities regulations, while others expressed troubling concerns and felt that they are not getting any help from their elected officials and the community board itself. Mr. Accomando stated that the Community Board has limited powers and that they are doing everything they can to advise the establishments goingforward. Notingthat Patrick Caruso has been diligently distributing countless emails and taking phone calls on a regular basis. Most establishments acknowledge the good work and the cooperation they have received from the office. One establishment expressed his concern that his restaurant has been inundated with countless inspections for no reason and believes he's being targeted for no reason. The committee found this very disturbing and Mariel De La Cruz from the Comptroller's office who was in attendance found this to be troubling as well, and will look into it and see if they can be of any assistance in this manner. We will follow up with her. At this time the chairman made a motion to except the renewals and itwas made by Mr. Bieder and second by Mrs. Chambers. The vote was unanimous.
