Project HED564, City Island Sub-Aqueous Water Main to City Island was presented by the New York City Department of Design and Construction. A power point presentation is available in the Board Office and notes project description, the scope of work, construction sequence, community impacts etc. Project is scheduled to begin in the Fall of 2019, projected end date is 2021.

Vincent Avenue Bulkhead Rehabilitation Project, NYC Economic Development Corporation: there are a set of project plans in the Board Office. At the present time, there are no project start/end dates as this project is pending approval from the NYS Department of Environmental Conservation. The process of bidding and construction will start after the necessary approvals are obtained.

JUMP Bike Program (owned by UBER), Ms. Eddy Wilson, General Manager of the Program presented a proposal for a dockless bike sharing program. There is an existing program in the central Bronx in the confines of Bronx Community Board #7. Costs are linked to an individual's UBER account; 30 minute minimum ride at 7 cents per minute; \$25 fee if taken out of area. The company would like to see it expanded to the Community Board #10 area and presented a request for a letter of support to be mailed to the New York City Department of Transportation Commissioner and Deputy Commissioner. JUMP Bikes has expressed a desire to branch out to communities where the Citi Bike program is unavailable. The committee voted to draft a letter of support with a majority approving, two opposed and one abstention.

“Resolved... at the recommendation of the Municipal Services Committee of Bronx Community Board #10 that a letter of support be sent to the Commissioner and Deputy Commissioner of the New York City Department of Transportation supporting the expansion of the JUMP Bike program into Community Board #10 and that be forwarded to the full Board for approval.”
