MINUTES OF MEETING HELD OCTOBER 16, 1986 IN THE MARY,

QUEEN OF PEACE HALL OF THE KNIGHTS OF COLUMBUS

The meeting was called to order at $8:08\ P.M.$ by Dominic Castore, First Vice Chairman.

I. Gallery Session

A. Mr. Lee, owner of toy store at 2147 White Plains Road (Disco City)

Mr. Lee spoke about the newsstand that was put up in front of his store. He stated that it had only been open for two days since it was put up.

Jay Nadler gave the Board a petition signed by the merchants on White Plains Road against the newsstand.

Several Board members spoke on the newsstand, and the District Manager gave the background on it. He stated that the Board had voted against it and he listed the summonsable infractions with the newsstand.

Emilian Eisdorfer stated that he had gone to Consumer Affairs and spoken with Ms. Coffey of License Issuance. He stated that Ms. Coffey informed him that her agency cannot do anything about the newsstand. Emil. stated that he had also spoken with Veralyne Hamilton of the Borough President's Office of Community Boards about setting up a meeting with the Borough President and the elected officals.

A great deal of discussion took place on this issue.

 $\mbox{\rm Mrs.}$ Lee spoke about the newsstand and what has transpired since its inception.

Annette Marchitello announced that the Department of Consumer Affairs would be holding a Public Hearing in the Rotunda of the Courthouse (161st Street Courthouse) on October 28thth at 9:30 A.M. to discuss restrictions for general vendors on various commercial strips. She suggested that people go to this hearing and address them about changing the rules and regulations regarding general street vending.

Dom named Jay Nadler to be on the Committee to attend the hearing.

II. Minutes

Correction

William Liblick stated that it was he and not William Ricevuto who made the Motion that Community Board #11 send a letter to the Departments of Traffic and Police and the elected officials asking that a police officer or traffic control agent be stationed at Pelham Parkway and Eastchester Road to regulate the traffic.

A Motion was made by Bob Black, Seconded by Eli Goldsmith - That the Minutes be accepted as received and corrected.

III. Chairman's Report - Dom Castore

Dom announced that Henry Yuspeh had resigned from the Board.

IV. District Manager's Report - Tom Brown

Tom reported that the Cabinet Minutes from the September meeting would be going out shortly. He stated that he had been busy preparing the Budget Requests to be voted on tonight.

V. Borough President's Report - Annette Marchitello

Annette restated that the Department of Consumer Affairs hearing on October 28th is to address the issue of general vendors on commercial strips and which areas should be restricted.

Annette submitted a copy of the Padavan Law to the Secretary. She stated that anyone having questions or needing clarifications can call Veralyne Hamilton. (Report available upon request)

Annette announced that:

- 1. The Board of Estimate had approved on September 25, 1986 a contract between the New York City Youth Bureau and St. Lucy's Community Action Committee, Inc. for the period of October 1, 1986 through May 31, 1987 for the provision of job readiness/placement services, team sports, arts and crafts, individual sports, and classes in drama.
- 2. The Board of Estimate had approved on September 25, 1986 a contract between the New York City Youth Bureau and Bronx House, Inc. for the period of October 1, 1986 through June 30, 1987 for the provision of recreation, basketball, cheerleader groups, and group counseling.
- 3. The Board of Estimate had approved on October 9, 1986 an agreement between the City, acting through and by H.P.D. and the Jewish Community Council of Pelham Parkway (Community Consultant Contractor) for the provision of technical assistance services which are complementary to and supportive of H.P.D. programs, thereby contributing to the improvement of housing conditions for residents of the City of New York.

VI. Committee Reports

A. Community Development & Budget Priorities - Robert Black

Bob reported that the Committee had met and discussed the budget priorities that were distributed earlier.

A Motion was made by Bob Black, Seconded by Leslie McHenry - That Community Board #11 delegate to the Community Development & Budget Priorities Committee the responsibility of making the Community Board's response to the Service Program Priorities (Form 3) based on the responses submitted by Board members.

Unanimous

Dom thanked Bob and his Committee for a job well done.

A Motion was made by William Liblick, Seconded by Raymond Locascio and Leslie McHenry - That Community Board #11 approve the priorities as prepared by the Budget Committee.

B. Public Safety - Joe Reda

1. Invitation to Commissioner Ward to attend the November Board meeting to discuss personnel levels in the Forty-ninth Police Precinct.

A Motion was made by Joe Reda, Seconded by — That Community Board #11 send a letter to Commissioner Ward inviting him to Community Board #11's November meeting to discuss the drastic shortage of manpower in the 49th Precinct.

Amended - That it be sent registered mail and that it include the need for more sergeants, and that it be sent to the elected officials and the that the District Leaders be invited.

Unanimous

Annette reported that the Borough President had met with Deputy Chief Ryan about the police needs for the Borough.

Joe reported that last week he had attended an emergency meeting with Inspector McKenna, Captain DiGregorio, elected officials and Precinct Council. He stated that he had a nine point Agenda.

Dom suggested that Joe and the Committee formulate an Agenda with questions to be asked, and sent it to all the Board members and the elected officials. He named to the Committee Joe Reda, Tony Rizzo, Eli Goldsmith, Norman Engel and the Public Safety Committee.

C. Parks and Recreation - John Cifichiello

1. Schematic Design for the Rehabilitation of Bronx Park from Adee Avenue to Pelham Parkway North and from Bronx River Parkway to Bronx Park East

A Motion was made by J_{Ohn} Cifichiello - Seconded by Bob Black - That Community Board #11 delegate to the Executive Committee the responsibility of responding to the Department of Parks and Recreation on the Schematic Design for the Rehabilitation of Bronx Park from Adee Avenue to Pelham Parkway North and from Bronx River Parkway to Bronx Park East.

Unanimous

C. Youth/Youth Services - Raymond Locascio

Ray reported that the Committee had met on September 22nd. He stated that a report

on the summer program was given by Tom Lucania. Ray stated that the summer program had gone very well. He stated that the Committee discussed additional information it had received on the Youth Bureau's Request for Proposals. Ray stated that Phil Abinanti of the School Board was there. He stated that the next Committee meeting would be on October 27th.

VII. Treasurer's Report - Raymond Locascio

Ray reported that the Treasurer's report had been distributed (Report attached)

VIII. Old Business

Bob Black asked about 2700 Boston Road which had been tabled at the last meeting.

District Manager stated that it was tabled until the November meeting at the request of the Allerton Avenue Merchants Association.
