MINUTES OF MEETING HELD THURSDAY MAY 31, 2007 IN LUBIN HALL

The meeting was called to order at 7:13 PM by Dom Castore, Chairman.

I. Gallery Session

a. Helene Samberg – Van Nest Branch Library

Ms. Samberg spoke about the proposed cuts in library funding for FY 2008. She stated that they are aiming for 6 day a week service and have a letter writing campaign going on for this. Ms. Samberg stated that the Summer Reading Club will be starting soon, and this year it includes adults.

b. Andrew Laioso - N.I.D.C.

Mr. Laioso spoke about a Public Workshop for Homeowners on Tuesday, June 12th at Lehman High School. He stated that this workshop is being sponsored by Neighborhood Initiatives Development Corporation and Councilman James Vacca. Mr. Laioso distributed flyers on this.

c. Mary Ann Potenzo

Ms. Potenzo spoke about wanting a street on Westervelt and Mace Avenues named for her father.

d. Rosario Puello – Friends and Family

Ms. Puello spoke about a Town Hall meeting that will be held on June $20^{\rm th}$ on Universal Health Care a Beth Abraham. She then distributed flyers.

e. Kay Cardona – 620 Reiss Place

Ms. Cardona spoke about the house at 631 Pelham Parkway North. She stated that they had problems with the previous owner who had the house as an assisted living facility. She stated that she wanted to know what he is doing there. Ms. Cardona also spoke about the temple/church on Reiss Place that is noisy. She stated that there was a fire there 3 weeks ago.

f. Kenneth Agosto

Ken reported that the 80th Assembly District will be holding its general meeting on June 7th at 7:30 P.M. at Liberty Tax, at 750 Allerton Avenue.

Ken reported that there will be a Bronx Asthma Walkathon on June 2^{nd} from 11-2.

g. Greg Kisloff – Pelham Parkway North Neighborhood Association

Greg reported that he had spoken to District 11 Sanitation regarding getting someone from their agency to come to his meeting. He stated that he was told he needed a letter from the Board to the Borough Commissioner in order for this to take place.

Greg spoke about the anti graffiti task force and stated that his group would like to help. He stated that they will have a cleanup on June 16th. John asked to coordinate this with Michael Carriere our Sanitation Chairman.

Greg spoke about the project on Brady Avenue and Antin Place.

John said that he is trying to get the contractors permit pulled.

Greg spoke about the ponding on Muliner Avenue

Greg asked if representatives from his group could be present at the meetings on Pelham Parkway.

h. Abigail Taylor – Leake and Watts

Ms. Taylor reported that on June 18th from 6-9 PM they will be holding a Connecting Families for Life event. She stated there will be 200 more children entering foster care by the end of 2007. She distributed flyers on the event.

John asked Ms. Taylor about an application that the Board received for 2 clients to be operated by Leake and Watts. He stated that he has been trying to reach someone about this.

II. Minutes

III. Chairman's Report – Dominic Castore

Dom thanked John and the staff for the job they have while he was away. He reported that we have 4 new members. Dom stated that he would be meeting with the new members.

Dom announced the passing of Raymond Marchitello husband of Board member Annette Marchitello. He asked for a moment of silence in his memory.

IV. District Manager's Report – John A. Fratta

John reported that he had attended a meeting held by the Borough President with P.S. 76. He stated the program is modeled after Counsel for Unity. John stated that the parents want some programs for parents.

John reported that a survey was conducted on how the schools are doing. He stated that the largest increase was in reading and math.

School Construction

John reported that while the school on Bronxdale Avenue is not open the Charter School will be opening in School. He stated that we do not know where the students will be going until the school opens.

John reported that he had met with Capt. Collins, Commissioner Aponte and Capt. Ortiz on May 4th regarding Mathews/Muliner Park. He stated that Capt. Collins has set up a new post at the park and on the block at night. John reported that PEP will be visiting the park.

John reported that all the horses except the 2 horses owned by Buster have been removed from the stables. He stated that the city property will be torn down to make green streets.

John reported that he had met with Rosemary Guinty of Waring Avenue to discuss the Botanical Garden which is very dilapidated. He stated that \$800,00 is allocated for the gate.

John reported that the Budget Process for FY 09 is beginning. He state that he will be setting up meetings with the agencies in our office to see what they need.

John reported that the District Needs Statement is due July 1st. He stated that he would be sending a copy of it to each Chair and give them the opportunity to make changes. He stated that at the June meeting they must be approved.

John reported on the house on Tieman Avenue and the problems with the sewer connection to their houses. He stated that he would be meeting with the Mayor's office, OEM, DEP and DOT.
