MINUTES OF MEETING HELD THURSDAY MARCH 27, 2008 IN LUBIN HALL

The meeting was called to order at 7:30 PM by Vincent Prezioso, First Vice Chair.

- I. Gallery Session
 - a. Gino Persichilli

Mr. Persichilli spoke about the Bocchi Court at Loretto. He stated that it needs to be renovated and have a canopy placed over it.

John stated that this would come up under the Parks Committee report. He said that Mr. Persichilli brought in petitions for this project.

b. Yamore Hurley

Ms. Hurley spoke about a house on Astor and Cruger Avenues which has a portable basketball court. She stated that kids are there from 3 pm until 11 or 12, and there is a lot of noise. Ms. Hurley also spoke about the cars that speed down the block, dog feces. She also said that there were no garbage cans on the corner, the graffiti in the area and the need for more police.

c. Greg Kisloff

Mr. Kisloff stated that he was concerned about where the fire took place on White Plains Road and Lydig Avenue. He spoke about the 197A Plan. He also spoke about Pelham Parkway being included in the rezoning. Mr. Kisloff spoke about traffic at White Plains Road and the towing process that is going to begin.

John stated that he me with the BID, Joe Thompson, the 49th Precinct and Traffic Enforcement. He stated that we expressed serious concerns about the towing. John spoke about people feeding the meters which takes away parking from would be customers. He explained about the tickets for double parking and the towing which would take place twice a month on the business strips.

Greg spoke about increasing parking by using the Maran Parking lot and not for resident parking only.

John discussed how the Board had looked into this lot. He stated if we builds up we will blocking the windows of residence whose buildings abut this lot.

Greg spoke about the ponding on Muliner Avenue.

John stated that the problem is the pitch of the sidewalks.

d. Siobhan Simpson - PHC Services LTD

Ms. Simpson stated that their office is located at 1005 Morris Park. Avenue. She stated that they were going to have a Health Fair on Thursday, April 14th from 11:30 AM to 4:30 PM at 1712 Garfield Street. Ms. Simpson distributed flyers on the event.

II. Minutes

III. Chairman's Report - Vincent Prezioso

Vinny reported that a Nominating Committee has been appointed. The Committee consists of Gene Tutor, Chairman and Rosemary, Linda and Annettte. He state that a slate will be presented at the April meeting. Nominations will be taken from the floor at the April meeting. At the May meeting nominations will be taken from the floor, but the person nominated must either be present or have indicated in writing their willingness to run. The elections will take place at the June meeting.

IV. District Manager's Report - John A. Fratta

John reported that the budget cuts got worse. He stated that at last month's meeting he had reported that the boards were getting a \$10,000 cut. There is now another \$6,000 cut. John stated that he is

trying to meeting with Speaker Quinn. He also reported that Shelly Silver is trying to put money in the budget to be earmarked for community boards only. John stated that \$16,000 is our whole OTPS allotment. He stated that he will call Speaker Silver tomorrow. John stated that we are fighting all the way.

Fire on White Plains Road

John reported that he is calling a meeting for next week with Buildings, Environmental Protection and the owner. He stated that there are major problems due to the asbestos. John stated that he is going to set up an on going task force for the demolition and rebuilding of the area. John reported that the zoning allows the owner to build higher than the present stores. He stated that we don't want this to happen. John stated that this is a C4-4 district which allow for taller buildings. He stated that he has not met with the landlord yet. John stated that he will let Greg know when this meeting takes place.

John reported that April 10th is the Anti Crime march.

John spoke about the area around the Botanical Garden. He stated that the Garden used to start at Bronx Park. John stated that the Botanical Garden would like to beautify this area. John stated that responsibility for this area rests with State and City DOT, Parks and the Botanical Garden. He stated that while the Garden will do the planting we are trying to get it maintained all the time.

Matthews/Muliner Park

John reported that the Board is on record as asking that the park be closed at 6 PM. He stated that the new signs say close at dusk. John stated that he called the Parks Department on this.

A great deal of discussion took place on this application, the problems with closing a main thoroughfare and the fact that it was a bus route. It was brought out that the businesses would have first choice to the tables which would be free to the merchants and the entertainment that would be provided.

MOTION PASSED WITH 20 FOR AND 4 ABSTENTIONS FROM ANNETTE MARCHITELLO, HAZEL MIURA, JOSEPH THOMPSON, SANDRA UNGER AND LINDA WHITE.

V. Treasurer's Report - Silvio Mazzella
