February 1, 2017 Parks & Recreation Committee Meeting Minutes

Meeting called to order at 7:00 p.m.

1. Presentation by Ishmal Guzman, Partnership for Parks/NYC Parks Literature distributed.

Grants are available for community projects; however projects must be used on parks property.

Earth Day clean up in April is considered an eligible community project.

Edith asked if there were other organizations that can donate shrubs for Earth Day event and Mr. Guzman suggested Green Thumb Program.

- 2. Update on reconstruction of Eastchester Gardens Playground: Estimate was provided by NYC Parks Department New Equipment for play area, safety surfacing, spray shower and drainage cost \$2.1 million. Reconstruction of Comfort Station Building with ADA access cost \$2 million.
- 3. Discussion concerning waiver of 40-day notice (RFP) regarding installation of vending machines at 1 Bronx River Parkway (Ranqua headquarters building).

Representatives from Parks Department explained that this location is in a remote area; staff would be provided healthy snacks and juices in the vending machines. This would be a positive alternative for staff and visitors attending meeting at this site.

After back and forth dialogue, the committee voted unanimously to approve written letter from Community Board 11 to issue waiver to the 40-day rule.
