Meeting called to order at 7:01 p.m.

1. Renewal Liquor License Application(s):

- a. Enzo’s Restaurant – 1998 Williamsbridge Road: Liquor, Wine, Beer, and Cider.

Applicant was present. 49th Precinct was consulted and had no issues.

Motion by Dominick Schiano, Seconded by Sandra Unger – Community Board 11 will send an email of *No Objection* to the New York State Liquor Authority (SLA) regarding this establishment. **UNANIMOUSLY PASSED.**

- b. TGI Friday’s – 1750-1780 East Gun Hill Road: Liquor, Wine, Beer, and Cider.

Applicant was present. 49th Precinct was consulted. There have been approximately 7 calls to 911 since last liquor license renewal.

Motion by Dominick Schiano, Seconded by Shradhanand Pirtam – Community Board 11 will send an email of ***No Objection*** to the New York State Liquor Authority (SLA) regarding this establishment provided that applicant submit the name of security company and copy of the licenses for the 4 rotating security guards to the community board office. **UNANIMOUSLY PASSED.**

- c. La Case Del Caffé Ltd. – 1036 Morris Park Avenue: Liquor, Wine, Beer, and Cider.

Applicant was present. 49th Precinct was consulted and had no issues.

Motion by Dominick Schiano, Seconded by Veronica Castro – Community Board 11 will send an email of ***No Objection*** to the New York State Liquor Authority (SLA) regarding this establishment. **UNANIMOUSLY PASSED.**

- d. JR Primos Restaurant Corp. – 698 Allerton Avenue: Liquor, Wine, Beer, and Cider.

Applicant was present. 49th Precinct was consulted. There were several issues addressed including:

- Patron was served to point of intoxication and went to the bar caddy corner from the establishment where he shot the owner.
- When police entered establishment on one occasion, four (4) teenagers locked themselves in the bathroom refusing to come out.
- Security guard was arrested for carrying a gravity knife which is considered a deadly weapon.
- Arrests on premises for possession of marijuana and prostitution.

Motion by Dominick Schiano, Seconded by Tony Signorile – Community Board 11 will send an email of ***Objection*** to the New York State Liquor Authority (SLA) regarding this establishment. One (1) abstention for cause by Veronica Castro. **MOTION PASSED.**

- e. Nuevo Imperial Restaurant – 2456 Williamsbridge Road:
Wine, Beer, & Cider.

Applicant was present. 49th Precinct was consulted and had no issues.

Motion by Dominick Schiano, Seconded by Sandra Unger – Community Board 11 will send an email of *No Objection* to the New York State Liquor Authority (SLA) regarding this establishment. **UNANIMOUSLY PASSED.**
