1. Renewal Liquor Licence Application(s):
  - a. Golden Eagle Restaurant, Inc, 975 Morris Park Avenue, Liquor, Wine and Beer  
Applicant was present. According to Chris Kirka, the 49th Precinct was consulted and has no objection. The CB11 questionnaire has not been filled out as of yet. Chris Kirka supplied the applicant with the questionnaire form, and it will be submitted by the end of the week. Motion by Joe Thompson, seconded by Joanne Rubino, that Community Board 11 send an email of No Objection to the New York State Liquor Authority (SLA), pending the submission of the questionnaire to the CB 11 office, regarding this establishment.

  - b. Roc Roc Corp., d/b/a Burger Time, 1080 Morris Park Avenue, Liquor, Wine and Beer
