The meeting was convened at 7:10 p.m.

David Leavitt stated that the community board created this committee at the last full board meeting to consider title changes and merit raises for the incumbent staff.

David Leavitt made a motion (seconded by Dominick Schiano) for the committee to go into executive session to discuss personnel issues. **PASSED UNANIMOUSLY**

The committee came out of executive session and considered the following motions:

1. David Leavitt made a motion (seconded by Dominick Schiano) that the community board approve a change in schedule from part-time (30-hours per week) to full-time (35-hours per week) for Community Coordinator Harriet Lasky with a new full-time salary of \$71,949. **PASSED UNANIMOUSLY**
2. David Leavitt made a motion (seconded by Dominick Schiano) that the community board approve a change in title from Community Associate to Community Coordinator for Chris Kirka with a new full-time salary of \$60,403. His new responsibilities will include support for the Pelham Parkway re-construction project and to learn about the new payment system used in the office. **PASSED UNANIMOUSLY**

3. David Leavitt made a motion (seconded by Dominick Schiano) that District Manager Jeremy Warneke be awarded a 3.5% merit increase (\$2,957) to his current \$84,514 salary making his new salary \$87,471. **MOTION FAILED** with two in favor (Leavitt and Schiano), two against (Aljayyousi and Walcott) and one abstention (Unger).
4. Janice Walcott made a motion (seconded by Sandi Unger) that District Manager Jeremy Warneke be awarded a 5% merit increase (\$4,225) to his current \$84,514 salary making his new salary \$88,739. **MOTION PASSED** with three in favor (Aljayyousi, Unger and Walcott) and two against (Leavitt and Schiano).

There being no further business the meeting was adjourned at 9:38 PM
