### 1. Renewal Liquor License Application(s):

- a. Bronx Italian American Cultural. – 2303 Yates Avenue: Beer and Cider.

- b. Mr. Q's – 2115 Williamsbridge Road: Liquor, Wine, Beer & Cider.

Applicant was present. 49th Precinct was consulted and had no objections.

- e. Kiraku Japanese Restaurant – 1048 Williamsbridge Road: Wine & Beer.

License expired in August, but it is believed that it has already renewed. Former Chair visited the establishment and was ignored. 30-day notice was received by CB11.
