1. November Meeting Minutes

- 2. Equity Committee Description
  - a. Reviewed the description and opened the floor for discussion.
  - b. Suggestions were made and edits will be made. An updated description will be sent to committee members.
- 3. Current Inequities
  - a. A spreadsheet was created and shared among committee members that noted issues within the community:
    - Train Stations
       ADA compliant issues (lack of elevators and/or escalators)
       with Allerton Ave, Morris Park, Pelham Parkway, Pelham
       Parkway/White Plains Road, and Bronx Park East stations
       in our area.
    - ii. Major Intersections

There are crossing issues over by Pelham Parkway/White Plains Road, Pelham Parkway/Boston Post Road, White Plains Road/Thwaites Place, Boston Road/Astor Avenue, Bronx Park East/Allerton, Allerton Ave/White Plains Road, Pelham Parkway/Williamsbridge, Morris Park/Williamsbridge, and Morris Park/Bronxdale.

- Suggestions were made to reach out to <u>DOT</u> in regards to looking into how we can get sidewalks, crosswalks and audio enhancements to help blind constituents.
- iii. Motion was made and seconded to recommend that CB11's Transportation Committee to look into the issues that were presented.

- b. The goal is to get the guest at our next meeting and further discussion will be tabled until then.

## 5. District Demographics

- a. Committee was e-mailed BxCB11 Census tracts information along with <u>Bronx Community District 11</u> information to give us insight on the members in our community.
  - i. This will be used as a resource to gauge who represents our community.

#### 6. Outreach to Schools

- a. Reach out to younger constituents (ages 16-24) and share with them information about the community board.
  - i. Plan is to draft an e-mail the committee can send out to schools to see if we can get input from the students.
  - ii. Come up with a list of schools to reach out to for the first round.

## 7. Getting New Members on the Community Board

- a. Committee wants to see if there is a way we can get access to people who are recommended to the board.
- b. City Council/Borough President has a certain number of members they can appoint.
- c. There is no minimum for members, but the maximum is 50.
- d. Further discussion was tabled until next meeting.

## 8. Community Board Bio Pages

- a. Currently 23 bios on our board's website.
  - i. This is a good tool to give constituents an idea of who represents them.
- b. Looking into getting a list of members who don't have bios up on the website and reach out to see if they would be interested in creating a bio.
