Meeting was called to order at 7:38 p.m.

1. Elevate Transit: Zoning for Transit Accessibility Text Amendment
The purpose of the meeting was for an explanation of the proposed
Zoning Text Amendment for people with disabilities a.k.a "Zoning
for Accessibility (ZFA) Text Amendment."

The amendment was presented by James Miraglia and Cate Contino. The purpose of the amendment is to improve accessibility to subway stations, making stations fully accessible for persons with disabilities in the most efficient way possible, while giving incentives for owners of adjacent properties to allow certain MTA easements on their property.

Most stations were built before 1950 and many are not accessible for individuals with disabilities. The amendment details the requirements for developers and/or owners who meet the specifications in the amendment to obtain certain zoning relief benefits such as possible additional floor levels and/or added square footage to their building.

The easement certification process would allow the MTA to create an accessible structure and/or route on a property that is within the station footprint but is not owned by the MTA. The system-wide Easement Requirement in most zoning districts, is for developments on sites of at least 5,000 sq. ft. and within 50 feet of a mass transit station. Additional Zoning relief may be allowed for sites less than 5,000 Sq. Ft in an applicable zoning district that voluntarily provides easements. Further zoning modification is subject to discretionary review and approval. An additional future text amendment on other issues will be brought before the Committee.
