Meeting was called to order at 7:35 p.m.

1. Report on Conference Call with Michael Smith of the New York SLA (State Liquor Authority)

The Committee Chair requested the call to clarify the Committee's responsibilities regarding liquor license applications.

The committee chairs—both present for the call along with Mr. Kirka—outlined the Committee's procedures to Mr. Smith, who was supportive of our efforts and said Community Board 11 went above and beyond what most community board's do.

Mr. Kirka pointed out that in the past if business owners did not show up to committee meetings, the Committee recommended disapproval of the liquor license application.

The committee members and Mr. Smith agreed that this is not a good enough of a reason to object to liquor license applications, since legally, applicants only have to notify the Community Board of their intent 30 days prior to filing their liquor license application.

Mr. Smith stated that the Committee and Board does an excellent job.
