  - Gun Hill Road Subway Station: Completed in January and open to the public
  - Trestle issue: Full review of the trestles issues will be conducted and a follow-up conversation will take place; emphasis made on how important and timely this issue has been for CB11
  - ADA Issue: No new stations to share; Equity Committee list regarding ADA concerns will be shared with City Transit
  - 24 Hour Service: Mr. Gonzalez is unaware if there is a timeline for 24 hours service being reinstated
  - Remaining questions/concerns:
    - i. How does Transit determine which routes the accordion buses run on versus smaller buses?
    - ii. Transit has been problematic in not notifying passengers with sufficient time on the 2 and 5 trains to exit the train before it skip stops
