J. Thompson: No past history of noise complaints. This is an isolated complaint. Therefore, no justification to do anything unless it becomes a pattern.

R. Press: Noise problems should be addressed by the police department. Otherwise it is a DEP matter.

Motion: No justification in citing La Palma for any wrongdoing. **UNANIMOUSLY PASSED.**

- 5. The Mayor's Economic Recovery <u>Blueprint</u>: the "administration, through the Office of Nightlife and in partnership with Borough President offices, will develop standardized questionnaires and processes for liquor licensing review at each Community Board."
 - D. Boahen asked whether the BID (Business Improvement District) in White Plains has started up.

- 6. Gallery Session (Public Input)
 - R. Press: Since Starbucks came in, Burger King and many other stores around Starbucks closed. White Plains Road has become like a ghost town.
 - J. Thompson: There are only several families which own the properties on White Plains Road. They tend to be absentee owners. Their rents are extremely high, and you have to be an established business in order to be able to rent on White Plains Road. It is up to the owners and the people who represent the owners to come up with the formula that makes it more accessible to businesses, especially start-up businesses. Therefore, up to the BID to get businesses to come in.
 - T. Deuling: Not aware of infrastructure projects R. Press mentioned but he will look into it.
