      - o Overall, up 19% this year
    - Year to date: up 41% over last year
    - Most notable crimes (# of arrests, if any):
      - o Break in on White Plains Road and Lydig Avenue (1)
      - o Rape on Bolton Street (1)
      - Shooting on Olinville Avenue and Thwaites Place
      - o Pelham Parkway Houses shoot out (2)

- D. Finch thanked O. Mederos and the 49th Precinct for their response to the shooting, from which, she stated, the whole community was affected.
- L. Garcia asked if there was a particular trend to the crimes.
- O. Mederos responded in the negative.
- R. Press asked if we need to bring back "Safe Streets" and about stats for Vision Zero.
- O. Mederos said he wasn't too familiar with the program, and he will provide stats at the next meeting.
- R. Delgado asked if rapes were investigated by the precinct or SVU (Special Victims Unit) and who keeps track of crimes on Parks Department properties.
- O. Mederos said SVU and the precinct keeps track but shares information with Parks.
- E. Rodriguez asked about traffic concerns on Stillwell Avenue.
- O. Mederos said there was no easy solution because businesses consider tickets a part of doing business.
- D. Finch asked if the precinct can paint over gang graffiti.
- V. Castro said that in Allerton, the Allerton Merchants can.
- O. Mederos asked Diana to send him the information.
