District Manager's Report September 28, 2023

Good evening Board Members and welcome back from your summer hiatus. Welcome to our newest Board Members. Community Board 12 received 15 new Board Members this year. We are now 45 Board Members strong. This makes our quorum requirements slightly higher at 23 Board Members in person. Tonight, is our second attempt at hybrid meetings. Some of you will recall our first attempt in June was met with some technical difficulties. Those participating online could not here us. I am hopeful that has been addressed and fixed by our production crew tonight.

As I write this I will not know if our training on Saturday, September 23rd was a success or not. One of your responsibilities as Board Members is to vote on things. Often times, we under a clock that requires the Community Board to vote in a timely manner. For example, the Community Board met with City Planning and discussed the Citywide Zoning Text Amendment on Carbon Neutrality but did not vote on it. That legislation is moving onto the City Council without the official input of the Community Board. Over the summer hiatus, the Bronx Borough President's Office voted in favor of the Text Amendment. It now moves on to the City Council for a vote. While there is nothing wrong with discussing and delaying votes to request more information; a vote will ultimately be required. You should use your positions as Board Members to be well informed prior to meeting on any given topic. To that end, Ursula and I have come up with ways to make that decision making process a little easier.

I am offering you a different vision on how we should be running our meetings. For some of you this proposal will be familiar. I have tweaked my proposal to address some of the challenges we face as a Community Board. It also attempts to take your time and commitment as Board Members seriously.

I am proposing the reduction of the number of committees to four from the twelve committees
our By-Laws state we have. This would allow us to increase the membership of each committee
substantially. These changes would facilitate more Board Members being knowledgeable about
items that made it out of committee. Currently, many of our committees are comprised of four
to five members which leads to longer discussions during Full Board Meetings where this is the
first time Board Members are hearing the item.

The four committees would be:

- a. Municipal Services Committee would hear all items related to city services. Concerns about service delivery from City Agencies, or the lack thereof, would be the province of this committee.
- b. Land Use and Housing Committee (Soliciting ideas for a better name for the committee) would hear all items related to housing, zoning, ULURP applications, transportation infrastructure projects and economic development items.
- c. Public Hearings Committee would serve to fulfill our requirement of holding Public Hearings every month. Every Community Board was audited last year and we were found to be in violation of the City Charter requirement to hold a Public Hearing every month. Our Full Board Meetings are not Public Hearings as ruled by the Comptroller's Office. These meetings can be used to provide trainings for our Board Members.

d. **General Board Meetings** – would remain the same as it is currently with the minor exception that we will no longer take public testimony. These meetings would be open to the public but public testimony would not be required. Our monthly Public Hearings would serve as the communities' outlet to voice their concerns.

Our calendar of meetings displays the breakdown of meetings and when they would potentially meet. If every committee were to meet as required there would be four meetings in the first week of the month, followed by three the second week of the month, followed by two meetings in the third week, followed by three meetings in the fourth week of the month. That's a lot of meetings and Board Members are required to be in person. I know many of you would rather participate from the comfort of your home. Community Board 12 is the one of two Board's Bronx-wide that offer hybrid. The other Community Boards opted to go in-person with no virtual component. I say all this to say that I value your time and the changes I am proposing comply with rules set in our By-Laws.

2. I am proposing additional changes on how to structure our leadership on the Community Board. The City of New York voted in 2018 on several charter amendments and one of those amendments involved term limits for Community Board Members. The first round of term limits will begin in 2027 with the following round in 2028. This means no one serving now can serve more than four two-year consecutive terms as a Board Member. To that end, I am proposing that the Executive Officers and Chairs be limited to serve as Chairs in their respective roles for no longer than one term (two years). Moreover, Executive Officers could not serve as Chairs of Committees and vice versa. This would allow a wider pool of Board Members to participate in the governance of the Community Board. Also, it divides the responsibility of the Boards Members equally.

I am offering these changes, but I am open to other ideas from Board Members on how we should be governed. I have been the District Manager since August 2015 and while our leadership at the top has changed some of our Executive Officers and Chairs have not changed. There are many reasons for this but it is my belief we must force ourselves to keep evolving.

Conclusion

Today marks my 2,979th day as your District Manager or 8-years, 1 month, and 26th day of my tenure here. I am grateful for each and every day at the Board.
