## District Manager's Report October 26, 2023

Good evening Board Members, I will try to be brief in my remarks this evening. I am grateful to the Executive Committee, last night we had a productive conversation about the reduction of the number of committees. I am hopeful that very soon we will be able to realize a better system that is thoughtful of your time and contribution to this Board. In that same vein, I do not want to forget about discussing the governance of the Board. I have copied and pasted the portion of my report about our leadership structure and the changes I am proposing.

#### **Community Board Governance**

1. I am proposing additional changes on how to structure our leadership on the Community Board. The City of New York voted in 2018 on several charter amendments and one of those amendments involved term limits for Community Board Members. The first round of term limits will begin in 2027 with the following round in 2028. This means no one serving now can serve more than four two-year consecutive terms as a Board Member. To that end, I am proposing that the Executive Officers and Chairs be limited to serve as Chairs in their respective roles for no longer than one term (two years). Moreover, Executive Officers could not serve as Chairs of Committees and vice versa. This would allow a wider pool of Board Members to participate in the governance of the Community Board. Also, it divides the responsibility of the Boards Members equally.

I look forward to continuing this part of the conversation. I believe in equity and that we must hold ourselves accountable before we set out to change the world.

Finally, I would like to discuss some housekeeping, our November meeting will be held on Thursday, November 16<sup>th</sup> at 7PM in observance of the Thanksgiving holiday. Similarly, our December meeting will be held on Thursday, December 14<sup>th</sup> at 7PM. Unlike our most of our meetings this will be a holiday potluck gathering. It will count as a Board Meeting so we will be taking attendance. We are required to have a meeting. The meeting will be opened, closed and the festivities will commence. It is a potluck, so I do hope you take the opportunity to bring and share a dish that has meaning to you. If you do not wish to cook or bring anything, you can contribute \$50 to help defray the cost of putting all this together.

#### Conclusion

Today marks my 3,007<sup>th</sup> day as your District Manager or 8-years, 2 months, and 24<sup>th</sup> day of my tenure here. I am grateful for each and every day at the Board.
