Bronx Community Board 12 January 26, 2023

The regularly scheduled meeting of Community Board 12, the Bronx was called to order via a Webex virtual meeting, at 7:01 pm by Chair Beatriz C. Community Board member Jean Claud was called on for Prayer. She was not able to connect. The Pledge of Allegiance was then led by VP2, John Isaac.

Assembly member and Speaker Carl Heastie greeted the Board with Happy New Year and notified the Board that the Governor would be introducing the upcoming budget. He also briefly discussed some possible changes with the current Justice system. Council member Kevin Riley also wished participants Happy New Year and shared the upcoming events in the district and encouraged participants on being more civically engaged in the community. In addition, he noted the recent success in being able to stop the Charter school Success Academy from displacing a school in the district.

1. Public Gallery Session

- QWPR- Had concerns about the state of White Plains Road and noted several businesses are suffering due to the Bike Lanes.
- Pedro Gonzalez (Bronx Community Health Network) introducing their services and their newest site on White Plains Road with planned opening mid-September. The main office is at 1 Fordham Plaza, Suite 1108, and his contact (646) 771-5505.
- Leah Gittens & Hayden (Women Creating Change) their focus is civic engagement in making it more equitable for women. Creating more opportunities for NYC women, making a more equitable New York. Women are their focus but all are welcome. Free workshops are available.
- Ayris Granby of Granby Funeral home had concerns on the bike lane traffic on White Plains Road and that they are creating hazardous conditions.
- Katherine from "I Raise Girls & Boys" noted upcoming event in the district
- Dr. Toba, President of the 47th Precinct Council shared about upcoming Breakfast Fundraiser on April 26th and the Precinct will be getting a new Commanding Officer.
- Dr Toba discussed with participants of the upcoming video release of an incident in Memphis, Tennessee. He noted that viewing the video might raise tension between the community and the police and encouraged persons not to be disruptive. In addition, he noted those cops in Tennessee have already been indicted.

III Community Board Chairperson's Report

The Chair thanked all for being here and noted all new members have been assigned or reassigned at this time and would like this time for the Chairs of Committees to introduce themselves and share briefly.

She noted that we had a quorum and that is why it is so important to be here.

- Judith Benitez (Economic Development & Business Services) This committee works with the businesses and the city agencies to promote business development. This committee also works with local businesses to review and approve liquor licenses request.
- Carla Borosotti (Environmental Concerns Committee) focus is on issues with immediate local community environmental concerns as well as broader issues impacting the environment. Local level trash complaints we escalate to DSNY and address other

- concerns with trash. Offering workshops on lead poisoning, home energy conservation etc. Rat mitigation is also a concern.
- Liaise with contacts of various agencies etc. Current curbside composting pick-up in the Bronx.
- Robert Hall (Housing Chair) Deals with Block associations and also Developers ensuring compliance with necessities in constructing new developments. He noted some types of housing are Affordable and low-income housing.
- Joan Claud (Libraries & Cultural Affairs) This committee introduces cultural programs to provide inclusion in the community for all.
- Karl Stricker (Chair Land Use) Land use deals a lot with developers and zoning in the community. Land use makes recommendations when request for rezoning is made. They are advisory only and their decisions are still subjected to the city agency.
- Denise Bond (Parks & Recreation Chair) Seeks to enhance Parks and Green spaces within the community.
- Alfredo Figueroa (Public Safety Chair) works closely with NYPD, Fire Dept and OEM. This committee works also with the Transportation Committee of CB12 as concerns for public safety also falls in line with many transportation issues.
- John Isaac (Transportation & Capital Projects) Transportation works with Education & Safety Committees. There are a lot of changes that will be coming into our community with the introduction of ebikes etc. Our aim is to see improvements in our community
- Tollyne Dickerson (Education and Youth Services Chair) Collaborates with community and private schools, colleges, universities, parents, or guardians to ensure positive educational outcome for our community.

January 19, 2023

Meeting began at 6:36pm via WebEx with Judith Benitez, Chair welcoming members and community-at-large.

We were joined by Ms. Cynthia Prisco, CB12 Liaison and Ms. Simone Jones, Chief of Staff for Councilman Riley who gave an update on the White Plains Road corridor.

Ms. Jones stated that a walk through the corridor was performed by Council Member Riley, Small Business Services Commissioner Kevin Kim and Council Member Julie Menon who is the chair of the Committee of Small Business Services for NYC was made to assess some of the needs of the businesses and get some feedback. Some of the needs regarded more support for Grants, the lack of support for services, i.e., sanitation. A local law created a One Stop Shop where all grants can be located grants and resources can be access through SBS portal. Councilman Riley hosted a You can get further information through Council Riley's office. Last Summer, Councilman Riley hosted an event with Bronx Collab.

During the summer Councilman Riley personally went to a lot of the auto body shops about complaints received from constituents about cars parking on the sidewalks and establish a dialog with theses auto body shops.

There is a grant that is available now and the deadline is January 30th for businesses sponsored by the Citizens Committee for NYC.

We would like to partner with the Community Board to have OATH come to this district to be helpful and triage summons received by the businesses in this area (e.g., sanitation and building violations). (April or May.) Ms. Jones indicated that they are working with Mosholu Preservation Team (Jerome/Gun Hill BID) to start a project where we will reach out to the

owners of the storefronts, not the renters, to figure out who the owners are and have them buy into the community (by upkeeping property) and maintain consistent communication with the community board.

We are working with Mosholu Preservation Team (Jerome BID) to start a project where we will try figure out who the owners are (not the renters of storefronts) and have the owners invest in the community with upkeep of their property and maintain consistent communications with community board as well as elected officials.

We are waiting for the new person to reestablish a link with MP Team/Jerome BID. The Council Member allocates funding for holiday lights and additional cleanup and outreach.

We then continued with the agenda. A cleanup item from last month.

The Economic Development Committee is recommending to the Community Board that they approve the application for New License of the Fronto Star Inc. located at 3376B Boston Road.

Fireside Pub was represented by Thomas Mulligan. The Pub is a family-owned business, been in the area since 1977. Run by Mr. Mulligan and his three daughters. Serve hamburgers, mozzarella sticks bar food. They have taken advantage of the Open Street/Dining Program. There is a shed on the street in front of their place.

Two, Two, Two Bar and Grill Corp, 3601 Boston Road was represented by Austin Howell and Michael Ferrari, Esq. Up for renewal license. All the documents except Stipulations was received. After discussion Mr. Ferrari and his client agreed to submit by Friday. It was received.

Discussion about dancing or live music in the district

Malcom Gray of Gun Hill/Jerome BID, MPC introduced himself to the committee. He is now the new Neighborhood Development Manager. Been in the job two weeks. Daniela Beasley who is the new executive director of MPC right now is covering White Plains Road area.

Question arose about work being done on Gun Hill Road between Laconia and Boston Road. Staff will check on this.
