Karl Stricker then made a motion that the Board supports the decision of the Economic Development Committee in sending a letter to object the license renewal for the establishment located at 4609 White Plains Road known as Last Stop Restaurant.

Votes were unanimous to send the letter of denial.

The Chair noted that there is still consideration for a gathering of Board members to get to know each other. She encouraged sharing your input.

There were no other concerns and the Chair invited member Joan Claud to close in prayer. Meeting closed at 7:45pm

Meeting began at 6:39pm via WebEx with Judith Benitez, Chair welcoming members and community-at-large.

John & Joe's Restaurant aka Last Stop Grill Bar located 4609 White Plains Road is up for renewal of license. Mr. Marek Schwedt, attorney represented for the owner. We informed Mr. Schwedt of several concerns from the Department of Buildings (Mr. Schwedt was aware) and the NYPD 47Pct report based on the history of incidents, the latest being a second shooting (fatal) that occurred. There were also many reports of incidents at this establishment.

The recommendation to the Board from the Economic Development Committee is to send a letter of objection to SLA to deny the issuance of a renewal license for Last Stop Grill Bar.

Establishment located at 707-709 East 235 Street, owned by Clifford Sutherland. This will be a new establishment. The Community Board and ED Committee have not received the CB application that is required to be filled out by the business owner. Until such time, upon receipt of these documents this new license will be tabled.

916 East 233 Street Sports Club Inc., located at 916 East 233 Street. The owner was not present. We will table this renewal until next month. There were questions that needed to be answered by the owner regarding the 47Pct report.

Lastly, update on Dspot Café new license, awaiting a determination from NYSSLA.

Meeting ended at 6:54pm.

CB12 – LIBRARIES & CULTURAL AFFAIRS COMMITTEE REPORT OF MEETING FEBRUARY 6, 2023

The meeting was called to order by Chair, Joan A. Clodd at 7:06 p.m.

Prayer was rendered by Ms. Clodd. Thereafter, she welcomed the attendees including Ms. Nereyda Franco, a health educator of Montefiore Health System. Ms. Franco did an excellent presentation on hypertension which is also termed as the "silent" killer since it does not always have symptoms.

Hypertension aka high blood pressure is a long term medical condition in which the blood pressure in the arteries is persistently elevated. Long term high blood pressure is a major risk factor for stroke, coronary artery disease, heart failure, vision loss, atrial fibrillation and other diseases.

Lifestyle changes and medications can lower blood pressure and decrease the risk of health complications. Lifestyle changes include weight loss, (if overweight), physical exercise, decreased salt intake, reducing alcohol intake, and a healthy diet.

The committee then continued with Black History Month celebration beginning with its history. February is Black History Month a federally recognized celebration of the contributions African Americans have made to this country, and a time to reflect on the continued struggle for racial justice.

Ms. Sadie Campbell, Vice Chair said she was too upset and sad to do a presentation especially when she thinks about the awful death of Tyre Nichols, a black man who died at the hands of five black police officers. Of course, we can all relate to that and as Mr. Andy King told Ms. Campbell, he understood her emotion and it was okay to feel that way.

The meeting was adjourned at 8:02 p.m.
