### **Board Minutes** February 26, 2015

#### I Call to Order

The regularly scheduled meeting of Community Board #12 (The Bronx) for February 26, 2015 was called to order at 7:41 pm at Town Hall, 4101 White Plains Road, The Bronx, by the Chairman, Father Richard Gorman.

The Chairman invited those wishing to participate to stand for the Pledge of Allegiance. He then asked for the Board and those community residents present to join him in a moment of silent remembrance and reflection for:

- Our District Manager Ms. Carmen Rosa, who continues to battle cancer.
- Reverend Samuel Simpson, one of the original leaders of the Clergy Coalition of the 47<sup>th</sup> Precinct, who passed away last week
- Mr. Earl Wilkinson, for many years the Board's Second Vice Chairman, who has been hospitalized
- Mr. Dulles Rakal, for many years the Sergeant- at-Arms of the 47<sup>th</sup> Precinct Community Council, and also an active member of Wakefield Taxpayers, who recently passed away
- And for our first responders the NYPD, FDNY, and EMT's -- who keep us safe, the members of our armed forces and veterans.

#### II Approval of the Minutes of October 23, 2014

Motion made by Mr. John Isaac and seconded by Mr. Robert Hall to approve the minutes of October 23, 2014, as printed with any necessary corrections, and to wave the reading of them.

#### Motion carried 22 Ayes and 9 Abstentions.

#### **III** Matters Arising from These Minutes

There were no matters arising from the minutes of October 23, 2014.



Father Gorman suggested that we as a Board should liaise more actively with other boards.

#### VI Committee Reports

#### **Economic and Business Services Committee:**

Chairman Mr. Felix Roldan reported on the new and renewal liquor license applications:

Representative from Smashburger who is seeking a new Wine and Beer License did not appear for their meeting with the committee.

**Motion made by Mr. Felix Roldan** to recommend to the New York State Liquor Authority not to grant a Wine and Beer License to Smashburger located at 847 Pelham Parkway.

#### Motion carried 27 Ayes, 1 Nay, and 6 Abstentions.

#### VII New Business

The family of the Honorable Sam Bea, Jr., Community Board 12's former district manager, and later a New York State Assembly Member, asked that Ely Avenue between Edenwald Avenue and East 233<sup>rd</sup> Street be renamed "The Honorable Sam D. Bea, Jr. Way".

Motion made by Second Vice Chairman Karl Stricker and seconded by First Vice President Mr. William Hall to write a letter of support to the New York City Council asking for

A report was issued for the December 2014 meeting, but there are no minutes due to the lack of a full quorum.

#### IV Council Member Cohen

Father Gorman welcomed Council Member Andrew Cohen. Council Member Cohen stated that he met with Commissioner Gilbert Taylor of the New York City Department of Homeless Services (DHS) regarding the issues at Project Renewal on Bronx Boulevard. He requested that a DHS Peace Officer be assigned to the facility to alleviate the burden on the 47<sup>th</sup> Precinct in responding to the high number of 911 calls.

He also informed the Board that he inquired about the status of the Muller Center. He reported that at this time there are no updates.

Council Member Cohen requested feedback on conditions at the Wakefield playground.

The Councilman stated that he is aware of the community's long-standing request for a youth center; he reported that his office has approved funding for Mind Builders. It is his opinion that while not a youth center Mind Builders will hopefully provide some useful support and services to the youth of the community. He invited feedback on the organization's performance.

He also stated that Assemblyman Dinowitz could not attend the meeting, but his office's Community Liaison, Ivan Nedds, was present.

#### V Council Member Torres

Father Gorman introduced the Honorable Ritchie Torres, New York City Council Member for the 15<sup>th</sup> District and Deputy Leader of the New York City Council.

Council Member Torres stated that he is responsible for a portion of Community Board 12's Olinville neighborhood. He stated that he is the Chair of the Committee on Public Housing and has previously worked as the Housing Director for Council Member James Vacca. The New York City Housing Authority (NYCHA) is the largest landlord in New York City.

Council Member Torres reported that he recently introduced legislation to attach fines to housing violations. He also introduced legislation regulating industrial laundries that service hospitals, restaurants and hotels. He informed everyone that contaminated laundries can pose a serious public health problem.

The Councilman's office also provides constituent services including a family law clinic, an immigration clinic, a domestic violence counselor, and free tax preparation help.

At the point Father Gorman welcomed Mr. William Rivera, the new Chairman of Community Board 9.

Forty-seventh Precinct. Officer Oswain had died of an illness that he had contracted as a consequence of his service at GROUND ZERO in the wake of the World Trade Center terrorist attack. The Council, nevertheless, wanted to give Community Board #12 an opportunity to be heard on the matter of naming the school.

The following names were put forward:

- The Honorable Sam D. Bea Jr.
- Police Officer Oswain
- Police Officer Michael Williams, the 47<sup>th</sup> Precinct officer killed on Bruckner Boulevard

A motion was made by Dr. Dena Robins, seconded by Mr. Robert Hall to propose the names above.

#### The motion carried unanimously.

The CEC is requesting a letter of support from the Board to support their opposition to the colocation of Bronx Charter School at M.S. 144

Motion was made by Mr. Karl Stricker, seconded by Mr. Robert Hall to support the CEC's request.

#### The motion carried unanimously.

The community organization Women of Woodlawn (WOW) requested the Board's support in asking Mosholu Montefiore Community Center to take over the property at 524 E. 236<sup>th</sup> Street between Webster and Vireo Avenues. They are proposing to re-purpose the property for Pre-K programs.

The community is concerned that the building, consisting of 400 square foot units, will be used as a homeless shelter when the owner is unable to find renters at the \$1400/month asking price.

Motion made by Ms. Norma Wiles and seconded by Mr. Carl Lazano to send a letter that Board supports WOW's request to use the facility for Pre-K ages.

#### The motion carried unanimously.

The Chairman asked the Board for approval to send a letter supporting Community Board 12's Response to the Mayor's Fiscal Year 2016 Capital and Expense Preliminary Budget requests.

Motion carried 24 Ayes and 8 Abstentions.

the addition of "The Honorable Sam D. Bea, Jr. Way" to Ely Avenue between Edenwald Avenue and East 233<sup>rd</sup> Street.

#### Motion carried 32 Ayes and 1 Abstention.

The New York City Department of Information Technology and Telecommunications (DOITT) provided notice that it intends to convert former public phone booth locations to free WIFI kiosks. There was debate regarding the pros and cons of this proposal. Some Board Members expressed concern that some of these locations are also active drug trafficking and prostitution locations, and as a result could facilitate illicit activity. There were also concerns that the kiosks would be vandalized.

Mr. Dana Driskell, The New York City Department of City Planning (DCP) suggested placing the kiosks near public housing projects because the service would be helpful to older residents who do not have cell phones. Mr. Dana Driskell confirmed that the locations generally follow the commercial backbone of the communities, and are placed near public housing because low income and elderly residents often don't have cell phones.

Other Board Members stated that they thought the kiosks were a good idea. Ms. Claudia Powell pointed out that on three separate occasions she lent her cell phone to people needing to call a car service.

Dr. Dena Robins commented that if the concern is facilitating drug trafficking we need to take an active stand and work harder to rid the community of the drug dealers.

Motion made by Mr. Karl Stricker and seconded by Ms. Barbara Gibson LeGrant to send a letter rejecting DOITT's WIFI kiosk proposal.

#### Motion carried 23 Ayes, and 10 Nays.

The chairman introduced Mr. Jeremy Cavanaugh, representing the office of Ms. Maria Lopez, School District 11 Superintendent. Mr. Cavanaugh reported that there are two new principals because there are two new schools opening. One of the schools is in the Van Ness section and one in Wakefield (P.S. 314)

Father Gorman reported that the Board was asked to recommend names for the Wakefield School.

The Chairman invited Board Member Mr. Theodore James to speak.

Father Gorman called upon Board Member Theodore Jones. Mr. Jones, in addition to being a member of Community Board #12 is also a member of Community Education Council #11 (C.E.C. #11). Mr. Jones reported that C.E.C. #11 had discussed at its last public meeting a name for the new Public School #314 (P.S. #314). The Council had voted to name the school after Police Officer Robert Oswain, who had served for many years on the school detail at our local

#### VIII Good and Welfare/Community Speaks

#### Ms. Shioban Francis, Wake Eden Baptist Church

Ms. Francis stated that she came to the meeting tonight to ask for the Board's support in opposing a liquor store planning to open at 1215 East 233<sup>rd</sup> Street at Baychester Avenue. She stated that this area includes a lot of churches and schools.

The Chairman responded that, if the area, is a commercial area then the store is as of right, and there is not much that the Community Board can do, except to use our economic power as a community and not buy there.

#### Ms. Farida Abdul-Wahab/Resident

Ms. Abdul-Wahab stated that she has lived in The Bronx all her life and this is her first time at a Community Board 12 meeting. She wanted to express her concerns regarding the lack of a youth center. She stated that it is really important to have a space for youth to use their energy.

She further stated that she has been having issues regarding the Dyre Avenue Number 5 train not being on time.

#### Note: Complaint has been submitted to the proper agency.

#### Ms. Kelly Vasquez-Council Member Andy King's office

Ms. Vasquez reported that Council Member King will host his State of the 12<sup>th</sup> District Address on March 12, 2015 at 7 P.M. at Beulah Church of God, 986 East Gun Hill Road. The address will highlight the district's finances, accomplishments over the past year, challenges facing the district, and future planning.

She also provided an overview of constituent services provided by Council Member King's office: immigration counseling, housing services, information on Bronx employment resources, and other services.

#### Ms. Ramos / Wakefield Library

Ms. Ramos stated that there are extensive free programs for adults, teens, and children at the New York City Public Libraries. She said that there have been some signs of gang activity in the area, and asked if there can be more police patrols in the area when school lets out.

#### Ms. Maxine Sullivan / Congressman Elliott Engel's office

Ms. Maxine Sullivan stated that the Congressman has office hours at Town Hall every other Friday. There is also an office in Coop City.

#### IX The Report of the Chairman

The Chairman reported that District Manager Carmen Rosa submitted her resignation on February 1, 2015. The new district manager should be in place by June 1, 2015. He further stated that he met with members of the Bronx Borough President's office regarding the qualifications needed and a process to be followed:

The New District Manager should have:

- Good collegial working relationships with Chairman and other Officers of the Board
- Familiarity with issues of The Bronx and particularly The Bronx
- Excellent knowledge of how city government works
- Ability to update office technology and office operating procedures
- Ability to provide professional and collaborative supervision of the Community Board staff
- Ability to maintain ongoing, regular communication with the Board and with local service chiefs
- Ability to communicate effectively with our local elected officials
- Must be available to meet with community groups and to attend events on weekends and evenings
- At least a bachelors' degree level of education
- Ability to speak or at least understand Spanish is desirable

The recommended starting salary range is \$65-70,000/year. There will be a six-month salary review.

The position will be published in *The Bronx Times* and the *Bronx News*, and the job description will be distributed to the community via email blast. Resumes must be submitted by mail, and postmarked by April 15. Resumes will not be accepted via email to preserve confidentiality.

The Screening Committee will consist of the 5 Officers of the Board. No staff members will be permitted to open any envelopes. Any Board Member wishing to apply will be granted an interview, but then must recuse himself or herself from the selection process. Any staff member wising to apply will be also granted an interview.

The Screening Committee will decide who they want to interview, and will keep a log of how they make their decisions. For candidates to be interviewed, the Screening Committee members will keep an evaluation sheet tracking candidates' strengths against requirements.

The Screening Committee will consist of the Chairman, the First Vice Chair, Second Vice Chair, Secretary, and Treasurer. The Screening Committee will select the top candidate, who will then be presented to the entire Community Board for vote of approval.

Board members will need to make their preference known by roll call vote, as it is a matter of the public record.

The Chairman informed everyone that a meeting had been scheduled with Project Renewal for tomorrow, February 27, 2015 but they cancelled on short notice.

The Chairman requested that if anyone is aware of abandoned buildings in the community, please inform Ursula at the Board office. The 47<sup>th</sup> Precinct is trying to compose a list of all vacant buildings.

Father Gorman reminded Board Members to make sure the office is alerted regarding phone or email address updates.

#### Statement from Borough President Diaz regarding Mayor de Blasio's 'State of Our City' Address

"We welcome Mayor de Blasio's announcement of committing \$200 million to the Lower Grand Concourse for the creation of 4,000 affordable housing units, site remediation, social programs and the redevelopment of our transit structure and infrastructure.
