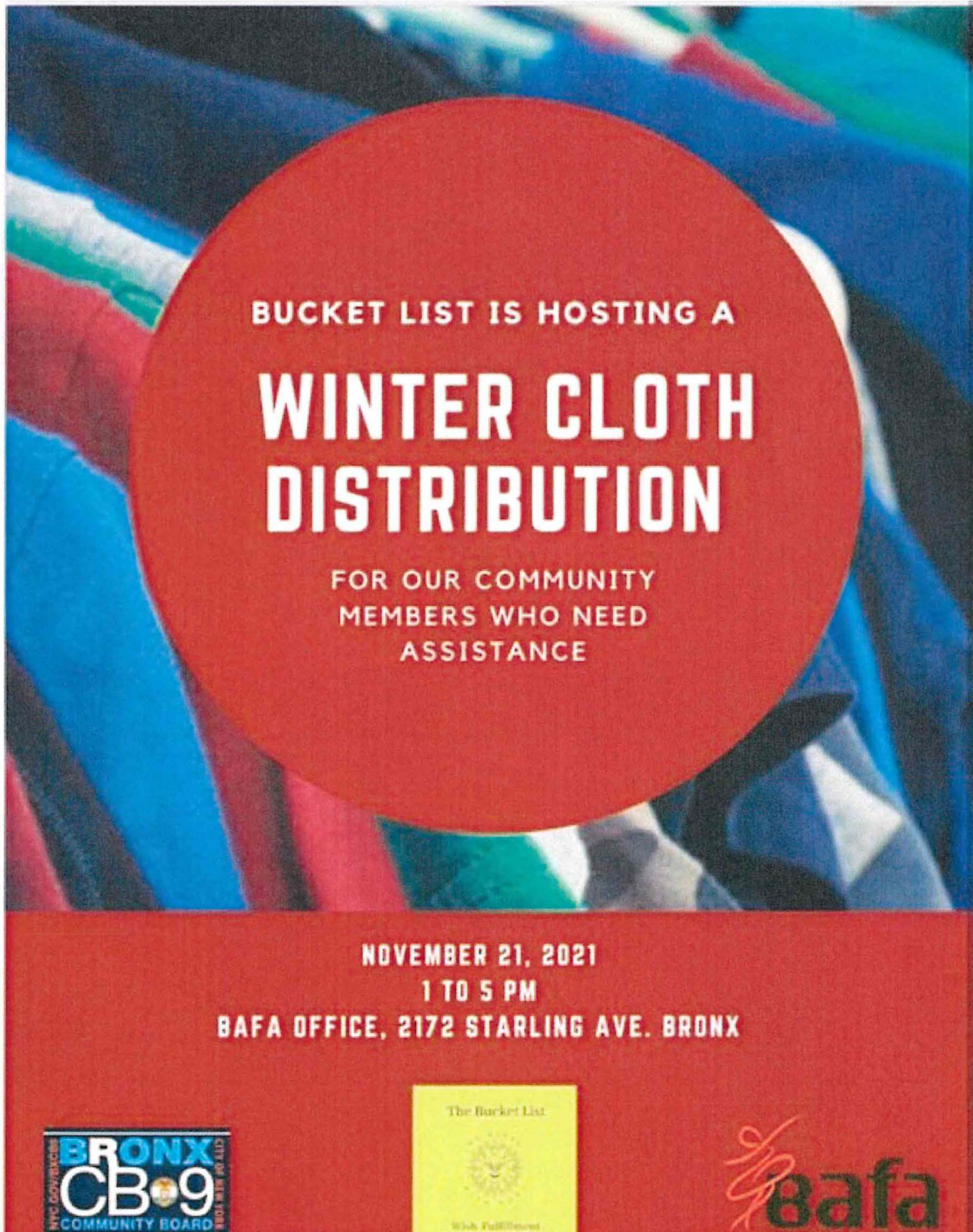

Sotomayor Community Center will distribute fresh produce and dry goods (rice, beans, canned vegetables and oats) to community residents and families.

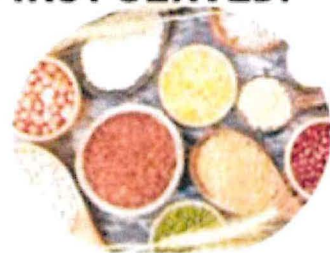

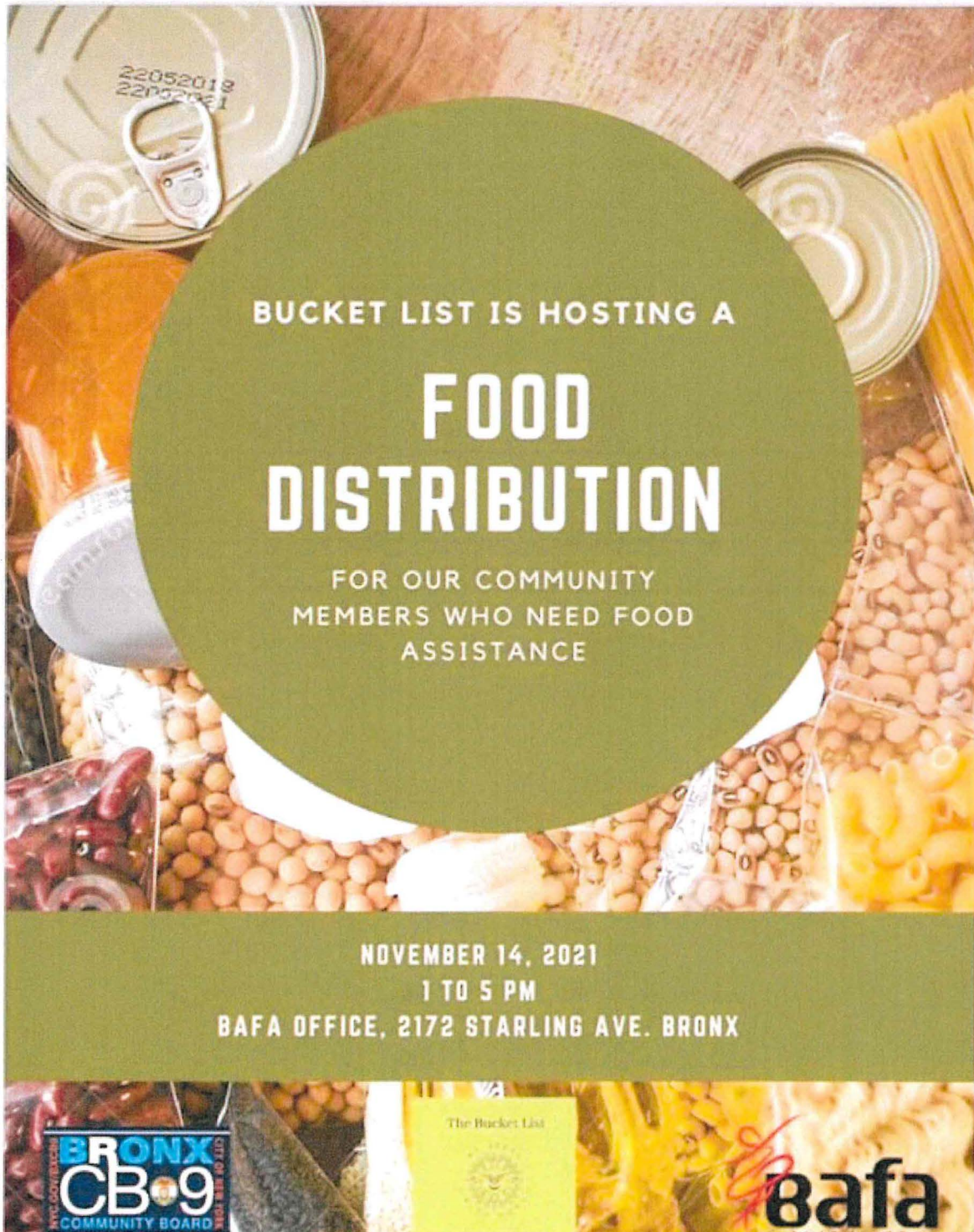

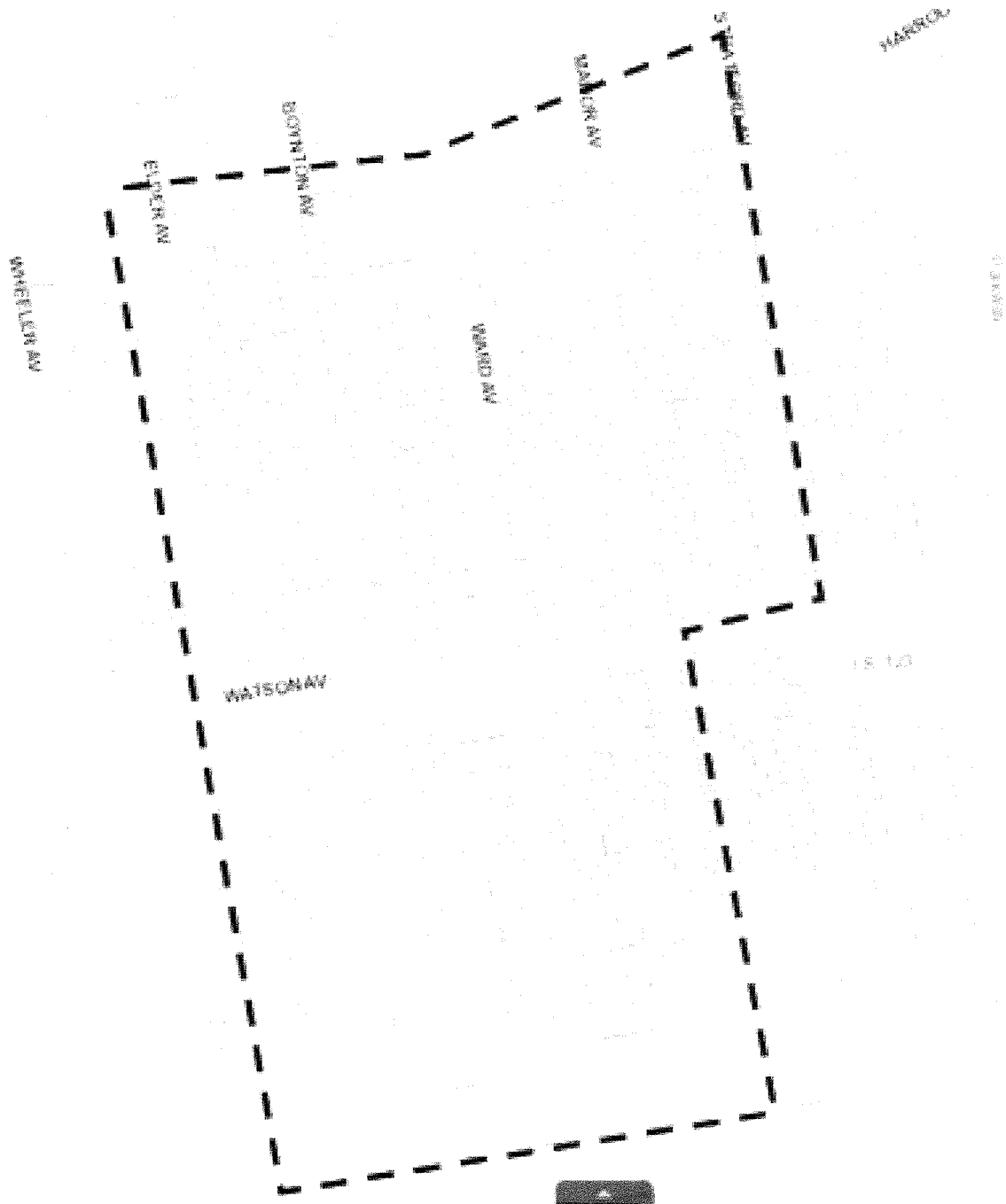

Please note DEP Water Distribution Operations will be supporting a test shutdown of a 20" water main in Westchester Avenue (Elder to Manor Aves) in the Bronx on Wednesday morning 11/10/2021. The shutdown is being conducted in connection with a sewer replacement project.

There is the potential for water pressure fluctuations and discolored water in the area outlined below. DEP will monitor the water pressure throughout the area and if there are any discolored water complaints, hydrants will be flushed as needed.

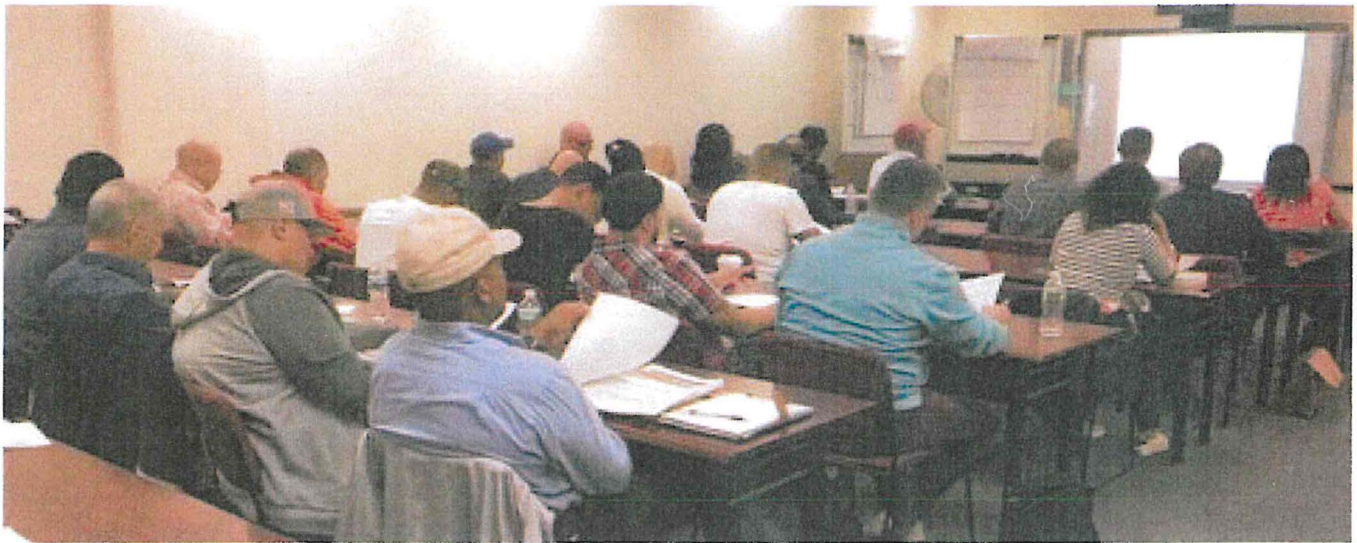

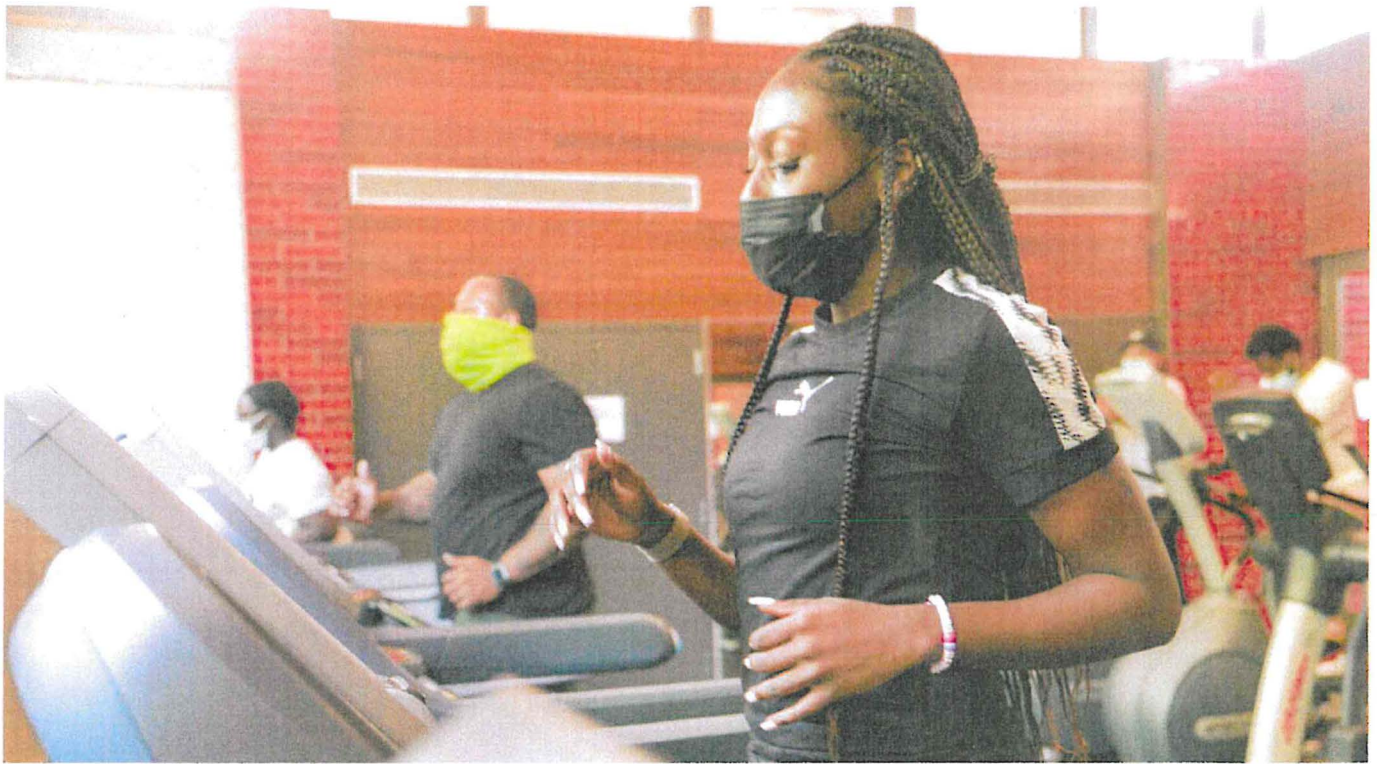

Claim Advance Child Tax Credit payments by **November 15, 2021**



Due to a change to the Child Tax Credit, families can get half of the fully refundable credit—worth up to \$3,600 per child—as advance monthly payments in 2021 and the other half as a refund in 2022.

If you did *not* receive advance payments and you were *not* required to file, you must sign up by **November 15, 2021** to receive payment in 2021. However, the sooner you submit information, the sooner you may receive payment.

Age of Child in 2021	2021 Advance Payment(s)		2022 Tax Refund

Important:

- Child must have a Social Security number (SSN). You can have SSN or Individual Taxpayer Identification Number (ITIN).
- You will get maximum payment amounts if you had no income or Adjusted Gross Income (AGI) up to \$75,000 (single filer) or \$150,000 (joint filers).

! **Did you have a baby in 2020 but last filed taxes in 2019?** Any advance payments you may have received are based on your 2019 return. Act by November 15, 2021 so the IRS can update your payment amount!

Are you receiving advance payments in 2021 but want to unenroll? To unenroll, use the [IRS Child Tax Credit Update Portal](#) at [irs.gov](#).

How to get your payment >>

To get payments, **you need to file a tax return even if you do not owe money**. You are eligible for payments even if you are incarcerated, experiencing homelessness, or have no income. The fastest way to get payment is by direct deposit to a bank account.

Next steps:

You filed a 2019 or 2020 tax return or used the IRS Non-Filer Tool



No action needed.

You are required to file a return but did not file a 2019 or 2020 tax return



File your taxes using **NYC Free Tax Prep**. See below.

You are not required to file a return because your AGI is under \$12,400 (single filer) or \$24,800 (joint filers)

NYC Public School Families Can Get a \$50 Monthly Internet Credit, Apply Now

Previously, we sent an email that did not have working hyperlinks. This email has corrected links you can use.

New York City public school families can [receive a \\$50 monthly discount on internet](#) broadband service and equipment. Families must [apply](#) and [find a broadband provider](#) in their area participating in the federal [Emergency Broadband Benefit Program](#).

Families can also check to see if their current internet providers are participating in the program. The broadband service then offers eligible families a discounted rate and is reimbursed by the federal government. Household can also receive a one-time discount of up to \$100 on a laptop tablet or desktop computer.

The Emergency Broadband Benefit Program began in May as part of the temporary federal COVID-19 relief response and will last until "the funds run out of money" or six months after the U.S. Department of Health and Human Services declares an end to the pandemic, whichever comes first, according to the program's [website](#).

Families that earned less than \$99,000 for single tax filers or \$198,000 for joint tax filers in 2020 qualify, as do families receiving benefits such as SNAP, or those who lost work last year.
