A. Health & Human Services Luis Marrero, Chair

Bronx Community Board #2 Health and Human Services Committee Minutes for April 1, 2025

Call to Order - The meeting was called to order at 6pm.

1. Introductions and Meeting Agenda

- Mr. Marrero, Chair of the Health and Human Services Committee opens the meeting, introducing the Health and Human Services Committee of Community Board 2.
- Various members introduce themselves, including Julia Cruz, Luis Marrero, , Roland Lopez, Lucresia Jones, Dr. Cooper Hart, Karen Jala, Emma Alexander, Marcia Peterman, and others.

2. Dr. Krupa Hart, DBA, MBA of Urban Health Plan presented their new Quick Care Service for the pediatric population

- Dr. Cooper Hart introduces the "Quick Care for Kids" service at Urban Health Plan, which has a 42-minute cycle time for patient care.
- The service operates Monday to Friday, from 8 AM to 6 PM, with a Patient Service Representative (PSR) available at 7:30 AM to ensure prompt registration.
- The Quick Care service treats conditions such as fever, vomiting, diarrhea, cold, flu, rashes, sore throat, earaches, stomach aches, asthma, and minor injuries.
- Follow-up appointments are scheduled if necessary.
- Dr. Hart highlights an expansion of services to include wound care, suturing, local anesthesia, and other urgent care needs.
- Patient satisfaction scores are shared, with high ratings for provider listening, reception, nurse courtesy, exam room cleanliness, and discharge instructions.
- The service sees nearly 3,000 patients per month, with plans to extend hours until 7 PM.
- Dr. Hart stresses the importance of continuity of care and follow-up with primary care providers.

Questions and Clarifications asked to Dr. Hart

- Mr. Marrero inquiries about whether new patients that it is doesn't have Urban Health Plan as primary care provider can be seen. Dr. Hart confirms that new patients can indeed be seen. Dr. Jones asks about the facility's location. Dr. Hart confirms the service is located at El Nuevo San Juan.
- Another clarification done was about vaccination services, and Dr. Hart explains that vaccinations are provided separately from Quick Care services to maintain continuity of care.
- Dr. Hart discusses the plans to expand Quick Care services to additional locations and include adult medicine.

2. Alejandro Cordero from Molina Health Care could not attend the meeting.

3. Marcia Biederman from the New York City Organization of Public Service Retirees requests a letter of support for a bill aimed at preserving healthcare choices for retirees.

- The bill seeks to ensure retirees have access to Medigap plans with benefits equivalent to or better than those available in 2021.
- Marcia Peterman outlines the challenges retirees face, including the city's plan to transition them to Medicare Advantage plans.
- The bill would codify retirees' rights to Medigap plans, addressing concerns about the city's financial savings goals.

Questions and clarification about the Bill

- The Chair of the Committee, Mr. Marrero seeks clarification on the bill's specifics and the need for a letter of support from the New York City Council.
- Marcia Biederman confirms that support from the City Council and other community boards is necessary.
- Dr. Jones and other members discuss the importance of supporting the bill, emphasizing a unified stance from the community board.
- A motion is made and seconded to support the letter of support for the bill, with all members in favor.
- Ms. Biederman was asked to come to the CB2 full board meeting in case any
 other board member has other questions. Since the motion was approved in the
 committee. Now, the whole body will need to vote for the letter of support and it
 will happen in the full board meeting.

4. Michelle Corona from Mount Sinai Center for Occupational Health promotes awareness of no-cost, confidential services for work-related injuries and illnesses, including occupational COVID-19.

- Services offered include medical exams, diagnosis, treatment, workplace hazard screenings, disease prevention education, and return-to-work accommodations.
- Michelle Corona highlights the importance of recognizing and addressing workplace hazards to prevent injuries and illnesses.

5. Announcements and Community Events

- Announcements are made about upcoming community events, including:
 - The 41st Precinct's Autism Awareness Walk.
 - St. Ignatius's Station of the Cross procession.
 - Annual prom dress and suit giveaway.
 - Child safety fair, hero's recognition breakfast, and the Bronx prom boutique.
 - Local initiatives such as the DEP's pilot program for commercial parking for overnight trucks and the emergency management commissioner essay contest.
- The importance of community engagement and participation in these local events is emphasized.

- Ms. Anita Reyes, Assistant Commissioner from the NYC Department of Health announces the expansion of services at the Morrison Avenue clinic, which now includes assistance with vital records, dog licensing, and immunization records.
- The clinic aims to provide personalized service to meet community needs, particularly during challenging times.
- These new services are available during regular business hours, with plans to expand to Saturdays based on community demand.
