#### Call To Order

Rev. Frederick Crawford, acting chair of Bronx Community Board Three, called the meeting to order at 6:14 pm.

#### Invocation

Min. Abraham Jones led us in prayer.

Rev. Frederick Crawford stated per the City Charter requirement Bronx Community Board Three will be hosting its Public Hearing on tonight. At this time, Ms. Rita Jones, Sqt. at Arms/Parliamentarian, will be keeping track of time.

Bronx Community Board Three has adhered to the requirement to post the "Public Hearing Notice" in a visible location for constituents to view, media outlets, CBOs, and community stakeholders, were sent "notices" electronically and the "notice" was uploaded on Bronx Community Board Three's Website, per the city charter, at least 72 hours prior to the meeting.

Rev. Frederick Crawford stated that the Public Hearings subject of discussion will be on ULURP Application #C220380HAX in the matter of an application submitted by the NYC Department of Housing Preservation and Development which requires board approval. The community-at-large and stakeholders will be given an opportunity to ask a question or comment on the presentation, once the Public Hearing is Open. Anyone wishing to speak can raise their hand or request to speak in the chat box.

Ms. Etta Ritter, acting assistant district manager at Bronx Community Board Three, stated that representatives from the NYC Housing, Preservation and Development agency along with Erickson Real Estate Inc. and JCAL Development Group came before the Housing, Land-Use and Economic Development Committee requesting that the designation of property located at 1312-1314 Chisholm Street (Block 2972, Lots 15 & 16) as an Urban Development Action Area (UDAA) and be approved as an Urban Development Action Area Project (UDAAP); and that the disposition of the city-owned project area (1312-1314 Chisholm Street) between Jennings and Freeman Streets, be developed into a 6-story, 23-unit co-op building to Erickson Real Estate Inc. and JCAL Development Group. This project is part of the Morrisania-Morris Heights Cluster site.

### **PUBLIC HEARING:**

Ms. Winifred Hamilton-Campbell, Deputy Director, Bronx Planning Office, NYC Department of Housing, Preservation and Development, stated that Sandra Erickson of Erickson Real Estate, William Bollinger and Josh Weissman from JCAL Development Group, and Mr. Jack Coogan from OCV Architects made a formal presentation at the Housing, Land-Use and Economic Development Committee meeting in May. At that meeting, a request was made to recommend approval of **ULURP APPLICATION #C 220380HAX**, for the development of 23 affordable homeownership units, at the General Board meeting in June 2022.

Ms. Hamilton-Campbell and the project team are requesting Bronx Community Board Three's approval for the designation of property located at 1312-1314 Chisholm Street (Block 2972, Lots, 15 & 16) as an Urban Development Action Area (UDAA); and for the disposition of the city-owned Urban Development Action Area Project (UDAAP) to facilitate the development of a six-story building containing approximately 23 affordable housing units; and for such disposition of such property to Erickson Real Estate and JCAL Development Group. The proposed development is part of a larger affordable housing project throughout Morrisania-Morris Heights, consisting of 12 residential buildings with a total of approximately 78 rental and homeownership units.

<u>U.L.U.R.P. APPLICATION #220380HAX</u> – The New York City Department of Housing Preservation and Development ("HPD or "Applicant") submits this application to facilitate a new approximately 20,626 square foot residential development. The proposed development will comprise approximately 23 affordable homeownership units ("Proposed Development") on Block 2972, Lots 15 and 16 in the Morrisania neighborhood of Community District 3 in the Bronx ("Development Site" or "Project Area"). The proposed development is part of a larger affordable housing project throughout Morrisania-Morris Heights, consisting of 12 residential buildings with a total of approximately 78 rental and homeownership units. To facilitate the proposed development, the Applicant proposes the following actions:

<u>Morrisania Open Door - U.L.U.R.P. APPLICATION #C 220380HAX –</u> In the Matter of an application submitted by the NYC Department of Housing, Preservation and Development (HPD);

- 1) pursuant to Article 16 of the General Municipal Law of New York State for:
- a. the designation of property located at 1312-1314 Chisholm Street (Block 2872, Lots 15, and 16) as an Urban Development Action Area ("UDAA");
- b. an Urban Development Action Area Project (UDAAP) for such area; and

2) pursuant to Section 197-c of the New York City Charter for the disposition of such property to a developer to be selected by HPD; To facilitate the development of a six-story building containing approximately 23 affordable housing units, Borough of the Bronx, Community District 3

#### **Community Concerns/Exchange of Information/Announcements**

Rev. Crawford has suggested that all community concerns and announcements be forwarded to Ms. Etta Ritter at <a href="mailto:eritter@cb.nyc.gov">eritter@cb.nyc.gov</a>, prior to the meeting. This is helpful to ensure a thorough and timely meeting. Rev. Crawford has also encouraged all board members to join a committee and become active.

Randy Dillard, a board member stated that the statewide Right to Counsel legislation is a campaign launched to transform the courts from evicting tenants to a place that upholds tenants' rights and holds landlords accountable and enables tenants to remain in their homes.

Ms. Marisol Duran, a community resident, and concerned citizen informed the board of her disapproval of an off-street parking lot by the New York Junior Tennis League at Crotona Avenue in Crotona Park. The proposed 11-car parking lot would be used by the sponsors who attend the Cary Leeds Tennis Center. Ms. Duran stated that residents were not given proper notice regarding the use of the park for the construction of a parking lot.

Ms. Duran noted residents within the community district did not have access to internet/Wi-Fi services during the time that this matter came before the Parks and Recreation committee. This community district has a high rate of people who suffer from asthma, the project entailed cutting down healthy trees and it would not be aesthetically pleasing to construct an 11-space parking lot at the proposed location.

It was noted by Ms. Ritter that this matter had come before the Parks and Recreation committee in February 2021 after several years of requesting additional parking from the NYC Department of Transportation. This has been an ongoing need since the inception of the Cary Leeds Tennis Center. The NYC Department of Transportation reconfigured Crotona Avenue and added a bike lane. This addition made it not possible to install angle parking. Again, after many meetings, the NYJTL officials spoke with the NYC Department of Parks and Recreation, and an agreement was made that the NYJTL would pay for the construction to build the parking lot. The project does not entail the cutting down of any healthy trees the NYC Department of Parks and Recreation only cuts down trees that are unhealthy and diseased.

Mr. Wali Abdun-Noor the director of the South Bronx Emergency Network has partnered with Chuck Frank, a professor at Metropolitan College in a Constructive Action Project to provide equitable broadband access. Undergraduate students who attend Metropolitan College will receive free broadband access via True Connect and Tablets that cost \$11.00.

### **Recently Introduced Legislation**

- Resolution 172 a resolution calling on New York State to increase the number of Commissioners on the Public Service Commission and
  permit New York City to appoint two of its Commissioners. As the Public Service Commission oversees the state's electric, gas, steam,
  telecommunications, and water utilities, allowing the city to appoint two commissioners to the commission gives the city a seat at the table,
  especially considering the recent Con Edison monthly bill hikes that have impacted so many New York City Residents. Reso 172 will be
  heard at the Committee on Consumer & Worker Protection on Friday, June 10, 2022.
- Introduction 362 a bill that would require the Department of Housing Preservation and Development to submit quarterly reports to the
  Council regarding affordable housing development project closings that involve any form of city financial assistance. The quarterly reports
  would include the amount of city financial assistance received by the developer, the date the project received ULURP approval, and the
  estimated and actual closing dates for any financial assistance provided by the City.
- Introduction 431 a bill that would require the Department of Homeless Services to provide biannual customer service training to all staff
  members, including those working for a provider under contract or similar agreement with the department, who have direct contact with
  shelter residents.
- Introduction 432 a bill that requires owners of multiple dwellings to annually inspect soil in areas on the premises of a multiple dwelling, partially or wholly covered in soil and accessible to persons other than those employed to maintain such premises. If the lead level of that soil is above the soil lead reference level, the owner must notify the Department of Housing Preservation and Development and cover, replace or remediate that area immediately.
