CALL TO ORDER

Ms. Etta Ritter, District Manager of Bronx Community Board Three, called the meeting to order at 6:09 p.m.

INVOCATION

Dea. Edgardo Cedeno led us in prayer.

PUBLIC HEARING

Adreina Baez, Domestic Violence Advocate, Bronx District Attorney Melissa Palacios, Domestic Violence Advocate, Bronx District Attorney Jasmine Jimenez, Strangulation Advocate, Bronx District Attorney

Topic: Discuss the Bronx District Attorney's Office response and support process for domestic violence cases

Ms. Melissa Palacios shared the following:

- Most Domestic Violence Unit (DVU) referrals come from within the District Attorney's Office. However, a small percentage of referrals are initiated from the community.
- DVU steps in after the defendant in the domestic violence case gets arrested.
- DVU client support is tailored based on the client's particular post-traumatic experience and their current state of mind.
- There are in-house therapists to assist with the client's case.
- Client housing needs are assessed and supported.
- DVU provides transportation to and from court.
- DVU assists the client with their Victim Impact Statement.
- DVU never closes a case and is always available to the client.

Ms. Adreina Baez stated the following regarding the Early Victim Engagement Program (EVE):

- EVE assists the client with crisis intervention during the arraignment process.
- EVE completes the client assessment, then the client is assigned an advocate.
- EVE consistently follows up with the client with frequent check-ins.
- EVE provides updated orders of protection for the client.

Ms. Jasmine Jimenez spoke on the following regarding Strangulation Advocacy:

- Most strangulation cases are also DVU cases and provide information about strangulation and the criminal justice process.
- The difference between strangulation and choking: Choking is when something is lodged in the throat, and strangulation is when pressure is put on the windpipe.
- The strangulation advocate's role is pre-arrest and provides information.
- Fifty percent of strangulation incidents do not reflect marks on the body.
- Strangulation is one of the most lethal forms of domestic violence.

At this time, the presentation was concluded.

Questions were entertained and answered satisfactorily.

PUBLIC SESSION

Announcements

Ms. Teresa Cunningham, Bureau of Community Affairs, NYC Department of Sanitation, made the following announcement:

- Separation of compost from trash is now mandatory. If you do not separate food waste from trash, you may get a warning.
- Starting April 1, 2025, all NYC residents will be subject to fines.
- Compost must be stored in the brown bin or the regular 55-gallon bin with the DSNY decal, which can be purchased online or at Home Depot.
- DOS recommends that only clear garbage bags be used to line the bins.

Tanya Osborne of CannaDiva made the following announcements regarding the organization:

- CannaDiva is a women-centered cannabis education company.
- CannaDiva represents the Cannabis Workforce Initiative, a NYState sponsored program that provides free workforce development training within the industry.

- Offers free 15-hour certificate training.
- Cannadiva is looking to liaise with organizations to inform the community about the program.

Alexander Reyes and Kimberly Troncoso of the Oyate Group discussed the organization's mission to eradicate poverty across New York and mentioned the Brandon Hendricks Scholarship.

In 2020, the Oyate Group launched the Brandon Hendricks Scholarship in honor of a rising star from our community who was killed by senseless gun violence on June 29th, 2020. Brandon Hendricks was a consistent source of hope and inspiration for everyone who knew him and had recently been accepted to college with a full scholarship. To honor Brandon's life, our organization offers financial scholarships in his name to multiple high school seniors from the Bronx who have recently been admitted to college.

Community Concerns:

A resident of 1409 Fulton Avenue has struggled with a lack of heat in her apartment for two years. She shared her information with the staff of Bronx Community Board Three for follow-up.

Queen Eva McFadden, My Sister's Keeper, thanked Bronx Community Board Three for their outreach regarding My Sister's Keeper Kwanzaa event in December 2024.

A staff member from the Dona Elsie Family Shelter expressed concerns about the lack of response to recent 911 calls. The staff member provided their contact information to the Bronx Community Board Three staff for follow-up.

A volunteer at the Jardin de la Familia, a garden overseen by GreenThumb, shared that there is a willow tree in the garden that needs attention, as its branches are hanging in a manner that could pose a risk to garden participants. The volunteer provided their contact information to the staff of Bronx Community Board Three for follow-up.

Mr. Aubrey Mike, a Bronx Community Board Three board member, spoke on the importance of the community being prepared in the event of an emergency.

ELECTED OFFICIAL'S REPORTS

Councilman Rafael Salamanca's Report

Ms. Shanna Knotts, Chief of Staff, shared the following written report:

Legislation:

Our office is currently working on drafting two pieces of legislation that will increase transparency surrounding e-bikes/scooter 'corral zones,' as well as legislation that will streamline emergency response efforts within city properties. Additional information on the bills are as follows:

In response to community complaints surrounding the placement of e-bike/scooter 'corral zones,' Council Member Salamanca is drafting legislation that would require New York City Department of Transportation to seek input from and notify community boards and local elected officials within sixty days of placing designated corral zones on city streets. These corral zones are designated areas created by DOT for bike/scooter users to place devices at the conclusion of their trips. While a step in the right direction from users indiscriminately leaving bikes/scooters in random locations, these corral zones tend to be on street corners that create tripping hazards and/or obstacles for pedestrians using crosswalks. The purpose of this bill would be to require DOT to seek critical input from local stakeholders as to what placement works best for that particular community.

Secondly, following efforts by municipalities and school districts across the country to streamline emergency response operations in emergency situations, Council Member Salamanca is drafting legislation that would establish the creation of a digitized, uniform emergency grid mapping system for New York City properties, including, but not limited to, New York City schools, hospitals, parks and government buildings. With a uniform grid mapping system, first responders, whether they be NYPD or FDNY, would utilize the same mapping system that takes into account site-specific features and geo-oriented navigation to streamline emergency response efforts and expedite response times. Too often, emergency responders are forced to rely on outdated hard-copy blueprints that lack detailed property characteristics and/or a defined navigational compass. This bill would change that, while also providing responders with a digitized mapping system.

Both pieces of legislation are in the final stages of drafting, with formal introduction estimated to be within the next month to month and a half.

Office Operations

CM Salamanca has partnered with DSNY for the E-Cycle NYC program. This a free service where you can discard electronics that you no longer need, want or utilize. They can be dropped off to our district office weekly from Wednesday – Friday between the hours of 10am – 3pm. A variety of electronics will be accepted, that don't include household items such as vacuums, microwaves, batteries, light bulbs or ballasts. Please refer to the flier with full details. This opportunity will remain available to community members, and residents for the next few months.



Councilmember Althea Stevens' Report

Lisne Bautista, Scheduler, Councilmember Althea Stevens' Office, provided the following written report:

Legislative Updates

- 1. Int. 794 This Local Law was passed by the Council to amend the New York city charter, in relation to the composition of the youth board has been enacted. This bill would require that appointments or recommendations for youth board members must be made with best efforts to ensure that appointees have demonstrated relevant experience in the area of youth welfare. Additionally, this bill would require that to the extent practicable, at least 3 members of the board be between the ages of 16-24, in order to ensure actual youth representation.
- 2. Int. 735 This Local Law to amend the administrative code of the city of New York, in relation to requiring the department of correction to report on sexual assault and sexual harassment of correctional staff and providing staff access to mental health treatment resources has been enacted. This bill would require the Department of Correction (DOC) to report on alleged incidents of sexual assault and sexual harassment by incarcerated individuals against staff working in City jails. For each incident, DOC would be required to report information related to the alleged incident and

related investigation. The bill would also require the DOC to ensure that staff have access to mental health resources relating to reducing stress and other adverse mental health impacts for persons working in correctional facilities.

Senator Luis Sepulveda's Report

Elizabeth Marte, Director of Community Affairs, shared the following written report:

Legislative Updates:

We are happy to announce that the Senator has a new initiative, Vision 32: Empowering the Bronx which encapsulates the capital projects the Senator is funding throughout the 32nd Senatorial District. The Senator has assigned \$5 million dollars to fund capital projects in the schools of the district. Part of this initiative includes advocating with Latinos United for Change and Advocacy aka LUCHA for dedicated funding to address the economic disparities that persist Latino communities within the district. This funding will support educational programs, workforce development, and language access initiatives—creating new pathways to success for countless Bronx families.

Additionally, the Senator was a cosponsor and supporter of Senator Sanders important legislation establishing the New York State Community Commission on Reparations Remedies which is tasked with examining the legacy of slavery, subsequent discrimination against people of African descent, and the impact these forces continue to have in the present day.

<u>S894</u>	SEPULVEDA Requires school districts to establish a language assistance program for limited English proficient parents of students.
<u>S240</u> <u>5</u>	SEPULVEDA Requires persistently dangerous schools to file an incident reduction plan detailing the steps the school will take to reduce incidents of violence and disruption.
<u>S246</u> <u>6</u>	SEPULVEDA Relates to guidance to facilities and programs overseen by state agencies on interactions with federal immigration authorities.
<u>S381</u> <u>7</u>	SEPULVEDA Establishes a temporary state commission to study and make recommendations on violence in state correctional facilities.
<u>S383</u> <u>0</u>	SEPULVEDA Relates to available transportation for correction facility visitation.

Congressman Ritchie Torres' Report

Ms. Joanna Rivas, Constituent Services Liaison, shared the following written report:

Congressman Torres announced today that he will be reintroducing the bill, the BODEGA Act, which will open up federal funds for bodegas to install security systems like panic buttons and ensure faster response times from the NYPD. Bodegas are the heart and soul of the Bronx and we must protect them from violent crime.

On March 8th, Congressman Torres reintroduced legislation to improve the federal response to health emergencies in light of the recent measles and bird flu outbreaks.

Congressman Torres is also advocating for the restoration of Medicare telehealth benefits which help so many senior citizens and their caregivers. Medicare recipients who use virtual or telephone options for doctors' visits will lose that benefit on April 1st. If you have a personal story on the impact of Medicare or Medicaid you would like to share with us, please call our office.

DISTRICT MANAGER'S REPORT

Ms. Etta Ritter, District Manager of Bronx Community Board Three, provided a written report which represents a summary of issues of importance affecting Bronx Community District Three for the period covering February 11th to the present:

NYC Bronx Borough President's Office

The Bronx Borough President's Office is hosting a **Call for Action** on Tuesday, March 10th from 7:00 am to 9:00 am at the East 174th Street train station to encourage Bronx residents to apply to their local Community Board. Approximately five members of Community Board Three have volunteered to participate and engage with the community on this matter. For the 3rd year in a row, digital applications are available in both English and Spanish for interested applicants. The deadline has been extended to Friday, March 21, 2025.

Volvy's Management Corp.

Volvy's management Corp. Intends to close Weiher Court from 3rd Ave to Washington Ave for Boom/Concrete Pump to be placed on the roadway for the new building at 1010 Washington Ave Bronx

This closure is scheduled to take place in the flowing days and hours March 9 2025 through April 10, 2025 two to three days a week (Monday to Friday 8am to 4pm)

JEK Communications

Cablevision has been contracted to conduct excavation work on the existing cable television infrastructure at **425 East 161**st **Street**, within Community District Three. JEK Communications is in the process of obtaining permits for this location and looks to start work within 7 days, with work not exceeding 14 days. Please be assured that all affected areas will be restored to their original condition upon completion of the work.

919 Freeman Street

Permits have been filed for a six-story mixed-use building at 919 Freeman Street in <u>Crotona Park East</u>, The Bronx. Located between Southern Boulevard and Intervale Avenue, the lot is near the Freeman Street subway station, served by the 2 and 5 trains. Westorchard Management is listed as the owner behind the applications.

The proposed 79-foot-tall development will yield 12,389 square feet, with 10,440 square feet designated for residential space, 1,730 square feet for commercial space, and 218 square feet for community facility space. The building will have 15 residences, most likely rentals based on the average unit scope of 696 square feet. Boaz M. Golani Architect is listed as the architect of record.

Demolition permits will likely not be needed as the lot is vacant. An estimated completion date has not been announced.

NYS Office of Cannabis Management
