Ms. Andrea Forde, Secretary of the Estella B. Diggs Democratic Club, shared time-sensitive information.

Ms. Lisne Bautisa, Scheduler in Councilmember Althea Stevens' Office, shared information about the 2026 Participatory Budgeting Cycle for Bronx Council District 16.

Mr. Aubrey Mike, a Board Member of Bronx Community Board Three, spoke on emergency preparedness. Mr. Mike noted the importance of maintaining emergency supplies, having food sources, and medicine.

Ms. Iraida DeJesus, Board Member, Bronx Community Board Three, noted the need for Gardenia La Familia, a community green space in Bronx District Three, requested assistance regarding a tree with hanging limbs inside the greenthumb garden needs to be pruned address safety concerns.

Ms. Beverly Emers, Board Member, Bronx Community Board Three, stated that she is working on a policy proposal to make parent engagement an allowable work activity for the Human Resources Administration's back-to-work requirements. The proposal was shaped out of Ms. Emers' personal experience and has been in development in collaboration with CUNY law welfare, writing initiative, and HRA leadership. Ms. Emers' wish is for the pilot program to be located in Bronx District Three. Ms. Joetta Brown, Chairperson of Bronx Community Board Three, recommended that Ms. Emer's share the information with the Bronx Community Board Three's Education Committee meeting.

Ms. Teresa Cunningham, Community Liaison, NYC Department of Sanitation (DSNY), shared that DSNY is taking a larger leadership role in how commercial waste is removed.

Councilmember Althea Stevens informed those in attendance about election ballot proposals #2, #3, and #4, which would strip the NYC Council and Community Boards of power.

Councilman Rafael Salamanca's Report

Ms. Shanna Knotts, Chief of Staff at CM Rafael Salamanca's Office, shared the following written report:

Legislation:

No legislation updates at this time.

In-District Recap

- On September 20, 2025, Councilmember Salamanca held a street co-naming for the late Serafin U. Mariel at Westchester Ave. Southern Blvd. Mr. Mariel was known for his exceptional success story, as he was a huge helping hand to the NYC's Latino Communities, and was able to administer more than \$750 million in loans to minority communities within the Bronx and Manhattan.
- On September 6, 2025, Councilmember partnered with DSNY to host a community shred event at his district office. The event was free and open to the public.

Office Operations

- Our office remains open and in full operation to offer a variety of constituent services. Those looking for assistance can give us a call, submit an email or visit us in person at the district office.
- We also have an immigration attorney available to provide constituents with free consultation and application assistance. However, this service is offered by appointment only. For more information or to set up an appointment please contact our office directly.
- CM Salamanca has partnered with DSNY for the E-Cycle NYC program. This is a free service where you can discard electronics that you no longer need, want or utilize. They can be dropped off to our district office weekly from Wednesday – Friday between the hours of 10am – 3pm. A variety of electronics will be accepted, that don't include household items such as vacuums, microwaves, batteries, light bulbs or ballasts. Please refer to the flyer with full details. This opportunity will remain available to community members and residents for the next few months.

LEGISLATION & GRANTS

Bills passed

- A429: Passed both Senate and Assembly and signed into law. The bill requires landlords to notify adjoining units of a bed bug infestation in a rental residential premises without identifying information, and to notify all tenants of an infestation in a common area by posting such notice in a conspicuous location accessible to all tenants.
- A4677-A: Passed the Assembly, Senate bill is in the Insurance committee. The bill requires insurance to cover lactation consultant services.
- A4159-A: Passed Assembly and Senate, not yet signed by governor. The bill Prohibits blocking certified peer support advocates, who were previously incarcerated, from providing treatment services in correctional facilities.
- A8254: Passed Assembly and Senate, not yet signed by the governor. This bill relates to training police officers on how to respond to situations involving individuals with autism spectrum disorder and other developmental disabilities.
- A8727-A: Directs the commissioner of education to conduct a study of recess held in elementary schools in kindergarten through grade six.
- A5524: Provides that an unsuccessful offerer may additionally request a written explanation comparable to such debriefing to be provided by mail or electronic mail, which the state agency shall provide within sixty days of the offerer's request for a written explanation; lengthens the period in which a debriefing shall be requested by the unsuccessful offerer and the length of time in which a state agency must respond from 15 days to 30 days.

June 2025 Highlights:

- June 5th: Hosted a Pastel, Seersuckers, and Sundress Day at the Capitol.
- June 9th: Hosted a Black Music Month Celebration at the Capitol which included a press conference, lunch, a legislative resolution introduction, and a floor introduction for legends such as Kurtis Blow, G. Keith Alexander, and Dr. Bob Lee on the Assembly and Senate floor.
- June 19th: Hosted a Juneteenth event in collaboration with the Black, Puerto Rican, Hispanic, Asian Caucus and the Office of NYS Senator Cordell Cleare at the Adam Clayton Powell Jr State Building in Harlem. During this event, we raised the Juneteenth and Black Liberation flags and had performances by local community groups.

2025 Legislative Session Highlights:

- Achieved 23 Budget Wins, including securing \$30 million to invest in underserved communities across NYS.
- Members advanced at least 16 bills addressing critical issues such as health, public safety, economic development, education, technology, and housing—each passing one or both houses of the legislature.
- Members introduced at least 15 legislative resolutions.
- Hosted 14 events in Albany

Community Updates

1. Participatory Budgeting - Deadline to submit is January 17th
 - a. \$1,000,000 in capital funds is spent within NYC Council District 16! Submit capital project ideas through this link. The ideas must range from \$50,000-\$1,000,000 in cost, have to have at least a 5-year lifespan, must be accessible to the public, and CAPITAL (not for programs - usually physical infrastructure)
 - b. Examples: school auditorium upgrades, tree fencing around a neighborhood public library, technology, park upgrades, HVAC for school cafeteria, etc.
2. Ballot proposals
3. Thanksgiving requests
 - a. Requests are still open
 - b. Tickets will be coming out in October

Legislative Updates

1. Introduced the following bills:
 - a. Int. 1423 - To amend the administrative code of the city of New York, in relation to requiring the Department of Transportation to provide an inventory of city-owned retaining walls under its jurisdiction.
 - b. Hood Caucus Int. 1424 - Local Law to amend the administrative code of the city of New York, in relation to prohibiting the denial of crime victim services to gang-affiliated individuals

S8523 - Protects New Yorkers from unnecessary inquiry into immigration status and restricting federal immigration authorities' access to state buildings.

- This bill codifies Executive Order 170 of 2017
- The order limited state involvement in immigration enforcement. While it is still active, we need to make this order law so that we are not taking the risk of these protections being rolled back by future administrations.
- It ensures that no New Yorker is asked about their immigration status unless absolutely necessary
- Federal immigration agents would no longer be allowed to make civil arrests inside state buildings, like courthouses or government offices, unless they have a valid judicial warrant.

S7719A - Enacts the End Bullying and Discrimination in Schools Everywhere (BEACON) Act

- Explicitly adds immigration status, including that of the student's family members, as a protected category under the Dignity for All Students Act
- Strengthens reporting and transparency by requiring schools to collect and report data on incidents of bullying and discrimination
- Directs the State Education Department to develop specific guidance and policies to address harassment based on immigration status

NEW BILL - DREAM Act Amendment

- We are working to introduce a bill that will eliminate the attendance requirement in the current DREAM Act.
- The current law states that students must have attended a NY State high school for two or more years. We are changing it to remove the 2-year requirement, and state that students must have graduated from a NY State high school.
- This change recognizes that many students, especially recent immigrants, transfer students, and those who moved to NY late in their education, still graduate from NY high schools and should not be penalized for shorter attendance.

By-Laws & Membership Committee

The By-Laws & Membership Committee reviewed official documentation concerning Ms. Jacquelyn Moore-Hill, including written complaints and correspondence from Board leadership. Based on this review, the Committee determined that Ms. Moore-Hill engaged in inappropriate behavior and conduct during and after meetings, including aggressive actions toward Board leadership, the use of profanity and unprofessional language in a public setting, and repeated efforts to circumvent established Board protocols. In light of these findings, the By-Laws Committee recommends her removal as a Board Member of Bronx Community Board Three, pursuant to Article III, Sections 4, 4A, 4B, and 4C of the Revised By-Laws.

The By-Laws and Membership Committee requests that the following motion be presented for a vote:

To move that Bronx Community Board Three adopt the recommendation of the By-Laws & Membership Committee and remove Board Member Jacquelyn Moore-Hill in accordance with Article III, Sections 4, 4A, 4B, and 4C of the Revised By-Laws dated January 14, 2025

Correction and Validation of Vote Count — Removal of Board Member Jacquelyn Moore-Hill

During post-meeting review of the October 14, 2025 removal vote, it was noted that Ms. Jacquelyn Moore-Hill, the subject of the removal proceeding, submitted a ballot that was unsigned and that she participated in the vote concerning her own removal.

Pursuant to Robert’s Rules of Order, Newly Revised (12th Edition) and Article III, Section 4C of the Bronx Community Board Three By-Laws, a member subject to disciplinary action or removal is entitled to speak in their defense **but must be recused from voting** on the question of their own membership status.

Accordingly, the unsigned ballot cast by Ms. Moore-Hill was deemed invalid and excluded from the final tally. The revised and validated vote count is as follows:

- Yes (to remove): 23
- No: 6
- Abstain: 3
- Invalid/Excluded Ballots: 4

Excluding the invalid ballot did not alter the outcome of the vote. A majority of appointed members present voted in favor of removal. Therefore, the motion to remove Ms. Jacquelyn Moore-Hill stands as valid and adopted, consistent with CB3’s By-Laws and procedural rules.

These corrections and validations were recorded for the purpose of maintaining transparency and ensuring procedural integrity of the Board’s actions.

Ms. Jacquelyn Moore-Hill requested that her full name be redacted, or that her initials be used, in all references pertaining to these proceedings. Her request is based on concerns regarding the preservation of privacy and potential implications of her digital footprint as it may relate to her current or future employment.

The Board acknowledged Ms. Jacquelyn Moore-Hill's request to have her name redacted, or replaced with her initials, in all references related to these proceedings due to concerns regarding her digital footprint and potential impact on employment.

The District Manager, Ms. Etta Ritter, noted the concern and informed attendees that, pursuant to the **New York State Open Meetings Law**, the names of participants in public proceedings constitute part of the public record and therefore cannot be redacted or anonymized. Ms. Ritter requested that Mr. Kenny Agosto, representing the Bronx Borough President's Office, seek clarification on the matter to ensure full compliance with applicable laws and procedures.

After brief discussion, the Board determined that no vote would be taken on this request at this time. The matter was duly noted for the record, and the proceedings continued in accordance with **Robert's Rules of Order** and **Bronx Community Board Three's By-Laws**.
