  - Spoke briefly about their organization's work, which is to provide college coaching from all phases of the college process (pre-college through college graduation). Ms. Johnson just retired from the Department of Education, previously was an English teacher, and encourages all to seek support from the organization despite the costs (they work with all income levels and even work for free).

Welcoming remarks and announcements by Ms. Beverly Bond, Board Chair. The Chair called the meeting to order at 6:17pm. Pursuant to Chapter 70 Section 2800 of the City Charter the actions and procedure of Community Boards and their committees are governed by the applicable provisions of the City Charter and New York State Open Meetings Law (OML, Section 100-111 of the New York State Public Officers Law) and Freedom of Information Law (FOIL, Section 84-90 of the Public Officers Law). Each Community Board shall meet at least once each month. Community Board 4 shall meet every fourth (4) Tuesday of the month, in person. This Tuesday, January 28, 2025, the meeting was held at The Bronx Museum of the Arts, located at 1040 Grand Concourse, Bronx, New York.

Roll Call for Board Members: Present 31, Excused 3, Absent 9 = Total Board Members 43

Report by NYPD 44<sup>th</sup> Precinct: Captain Ortiz-NYPD 44th Precinct provided a report from the last 30 days (12/30/2024 to 01/26/2025) where there was a 10% decrease in crime, measuring the number of robberies, burglaries (21 versus 18), and homicides (72 versus 72) in our area. Year to date (January 1st-28th, 2025) there has been an 11.6% decrease in crime. Captain Ortiz will deploy an overnight patrol along the Grand Concourse and Franz Sigel Park to monitor and observe the car break-ins mentioned during the meeting's Q&A. Captain Ortiz took a question about ICE raids during the meeting's Q&A and noted that NYPD knows they are being conducted, they just don't know when and don't have much direction other than not to get involved.

## Report by the Office of the Bronx Borough President and Local Elected Officials:

- 1. Alexis Ruiz, representing Bronx Borough President Vanessa L. Gibson
  - Ruiz has already reached out to all Board Members who are up for reappointment this year. The Borough President's office is also accepting applications for new community board members. The deadline for both applications is in March 2025.
  - The Committee on Open Government is hosting training sessions that could be beneficial for Board Members in two sessions: from 10am-11am EST and 1-2pm EST.
  - Savor the Bronx is returning this year and flyers with more information are available on the back table.
- 2. Socrates Solano, representing Mayor Eric Adams
  - There is a surge of NYPD police in the city's subway system, 300 police officers who will be checking/inspecting MTA train carts during midnight hours (12AM-5AM). They will be paid overtime from the Governor's office. This is being called a "search." It is unknown how long this will last, but anticipated until when the public feels "safe."
  - Since Mayor Adams took office, there have been 20K guns taken off the street (both ghost & regular guns); 3K more than the previous administration.
  - The mayor working on securing a development partner for the affordable housing project that is coming to the Grand Concourse Library.
- 3. Gloria Cruz, representing NYC Council Deputy Speaker Diana Ayala
  - Shared flyers for Deputy Speaker's constituent hours, services provided, and on-site clinics in East Harlem and South Bronx. Their office does offer free immigration services and Gloria is the lead contact for the Bronx office.
- 4. Sommer Bedford, representing NYS Senate Jose M. Serrano
  - The Senator is currently in Albany for the current session and spoke briefly about updates when it comes to budget proposals, such as Parks.
  - The Senator is participating in an upcoming virtual forum with other Senators from the Bronx and encourages everyone's attendance.
  - District Office- 335 East 100<sup>th</sup> Street bet. 1<sup>st</sup> and 2<sup>nd</sup> Avenues, Mon.-Fri. 9AM to 5PM, (212) 828-5829 or serrano@nysenate.gov
- 5. Tamar Rothstein, representing US Congressman Ritchie Torres

- Discussed the federal funding pause at the time; their office does not expect SNAP to be affected but should anyone face issues with their benefits to reach out to their office to see if they can assist.
- No info on the ICE raids but to reach out to their office to see if they can assist if you or someone you know if affected.
- Congressman Torres was involved in helping the victims of the recent fire on Willis Avenue.
- 6. Jumanah Escalera, representing Bronx County District Attorney Darcel D. Clark
  - DA Clark held a reentry fair today where professional attire was given to fair chance candidates and mock interviews were conducted with ADAs.
  - DA Clark's annual prom clothing drive is coming up and donations will be accepted for that drive soon.
- 7. Yudelis Moronta, representing NYS Assembly Landon Dais
  - The Assemblyman is currently in Albany. Their office took a brief break for the holidays and discussed their recent accomplishments (e.g. provided turkeys and toys to the community during the winter holiday season).
- 8. Esperanza Diaz, representing NYC Council Oswald Feliz
  - Discretionary funding is still available through their office and those interested are encouraged to apply.
  - Free citizenship and immigration services are available through their office.
  - Housing attorney services are also available through their office.

### **New/Unfinished Business:**

 Rev. Julian Stephenson spoke about the fear the community is facing right now because of the ICE raids. Those with information on how to be prepared are encouraged to share that information with the Board so they can share it with the community.
