Public Hearing on the ULURP APPLICATION FOR Claremont House: 1640 Anthony Avenue (Block 2888, Lots 23, 21, and parts of Lots 28, 50, 58) Nos. C 250220HAX, C 250221ZMX, and N 250222ZRX

- This hearing is mandated by the city charter. An Urban Development Action Area (UDAAP) and disposition, a Zoning Text Amendment (MIH), and a Zoning Map Amendment (from R7-1 to R8) to facilitate a new 13 story residential building, with a total of approximately 65 homeownership units, is being sought by NYC Dept. of Housing Preservation & Development (HPD) at 1640 Anthony Avenue in the Claremont neighborhood, Community District 4, Borough of Bronx.
 - o C 250220HAX; IN THE MATTER OF an application submitted by the Department of Housing Preservation and Development (HPD)
 - 1) pursuant to Article 16 of the General Municipal Law of New York State for:
 - a) the designation of property located at 1640 Anthony Avenue (Block 2888, Lot 23) as an Urban Development Action Area; and
 - b) an Urban Development Area Project for such area; and
 - 2) pursuant to Section 197-c of the New York City Charter for the disposition of such property to a developer to be selected by HPD; to facilitate the development of a 13-story building containing approximately 65 income-restricted units, borough of the Bronx, Community district 4.
 - C 250221ZMX; IN THE MATTER OF an application submitted by the Department of Housing Preservation and Development pursuant to Sections 197-c and 201 of the New York City Charter for an amendment of the Zoning Map, Section No. 3d, changing from an R7-1 District property bounded by a line 175 feet southerly of East 173rd Street, a line 90 feet easterly of Anthony Avenue, Belmont Street, and Clay Avenue, as shown on a diagram (for illustrative purposes only) dated May 5, 2025, and subject to the conditions of CEQR Declaration E-809.

Claremont House Project Presentation – new 13 story residential building, 65-unit affordable homeownership project - Located at 1640 Anthony Avenue - Developed by Habitat for Humanity - Seeking zoning changes from R7-1 to R8 - Targeting AMI levels 60-90%, Borough of the Bronx, Community District 4.

Discussion:

- Some board members expressed concern about the high AMI relative to local incomes, especially as the Bronx has one of the highest poverty rates nationally. Presenters noted that homeownership AMIs tend to be higher due to the nature of financing and the lack of federal subsidies.
- Parking concerns were also raised due to the already congested neighborhood.
 Developers chose to prioritize unit count over parking, noting that adding parking would

- reduce the number of units by 10–20. Conversations with DOT regarding possible off-site parking were ongoing.
- Questions from the board also addressed the accessibility of the units for recent college graduates and lower-income families, to which the developers responded that co-op responsibilities and maintenance fees may make units inaccessible to very low-income individuals, but subsidies and long-term tax abatements may help ease the cost burden
- o Further questions focused on transparency in marketing income levels, how tax abatements will help affordability, and where the project currently stands.
