## **REPORT BY ASSEMBLY MEMBER LANDON DAIS:**

- ❖ Shared office location and his legislative duties in Albany and constituent services/resources in the district. The district holds the highest rates of evictions and noted energy prices are going up. Food insecurity is also very prevalent. Funding successes: \$2.5 million for BronxWorks. New Settlement fixing their pool. Bring more artistic programming to Hip Hop Museum and Bronx Children's Museum. AM Dais noted the DMV is relocating from Fordham Road to the Bronx Terminal Market on October 1st. Veteran's rally on September 30th. Discussed legislative items RE: surrogate judges.

  - Ribbon cutting for the new 9million field at taft campus.
  - among many more projects.
- ❖ The 149th Street Bronx general post office will be an extension of Hostos Community College for Life Sciences building.
- ❖ Talked about interagency collaboration; Allocating money to DSNY for illegal dumping cameras.
- ❖ Collaborating with bodegas for healthier foods. Discussed getting healthy foods with health bucks.
