#### • District Managers by Ken Brown:

Reports: Good Evening, all board members. Initiatives we're currently involved with the board members mentioned more resources. The district had meetings with the Department of Health Center to discuss growing and bringing the event, even if you call the Share program, where you get paid fresh produce. NYC has a relationship with a local farm. The walk is planning some activities on November 13. There was a gardening day that will be starting at West 183 street and aqueduct. On November 13 at noon, the friends of the aqueduct walk and university woods and devote Park received a donation of 1000 Flower bowls. Friends of the aqueduct walk also plan a Community Heroes exhibit at the Roscoe Captain Roscoe Brown Plaza on December 4, 2021. One of the commitments that came out of the Jerome Avenue rezoning was to develop a Housing Preservation task force. The Borough President's office, Council Member Vanessa Gibson and housing preservation and development met for approximately a year - they met through May of 2021. The contract with Chaska and Northwest Bronx Community clergy association to do tenant organizing in apartment buildings throughout the borough that throughout the west part of the borough that identified as being physically dilapidated, so they came up with their financial report. The Jerome Avenue Revitalization Task Force, it's been continuing to meet before Jerome Avenue. The coalition is the ad hoc banking working group. We have been conversing with Amalgamated Bank and Chase Bank to ensure that some financial services remain to the district.

## 46<sup>th</sup> Precinct Community Affairs Captain Piper, NCO Sergeant Garcia:

Reports: The batteries from the scooters are costly, about \$1,600, and they're not secured very well. A lot of the crime is you can rip one out of the scooter. There is a rise in crime, most recently with grand larceny, involves students. We have gone out to all the auto shops and notified them that purchasing one of these batteries is illegal. And we're also working on the other end of trying to stop this thing while it's happening. We have a new special operations Lieutenant, DeSoto, and he has hit the ground running well. And he's been doing some operations trying to catch people in the act using scooter thefts batteries for revenue. There hasn't been any luck yet, but we're pretty sure something that's going

to happen. With that, I'm on the other end of our grand larceny increase. We're also looking at shoplifting on Fordham Road and at the Rite Aid on Burnside. He has had success with conducting operations and catching people shoplifting, and there have been several arrests. Thanks for our CO Seminara. The current CO has also been working with corporate security with a lot of these stores. On Fordham looking at better solutions for stopping people before they can even caught in the act. Other crime has been down for the year about 10.6% within 28 days what we're looking at mostly for is grand theft. The Police Department always has a policy for Halloween. We will have the maximum amount of people available and working. This is Sergeant Garcia please come join us, we will be giving out many candies to the children. Would you please bring your family to come to join us for a trick or treat?

# **Public Session**

- Sallie Smith- Resident Reports: I heard things that are my concern I was listening to this morning. The Department of Parks time that they got so many millions of dollars and you know that we have Echo Park project over there that was never finished and that they removed the comfort station and never put it back. They claimed the Parks does not have enough money. Could we get some extra funds to complete our project and compensation back in Echo Park and some staff members?
- Lutheran Social Service of New York by Georgia Katsalis:

Reports: Good evening. Board Members and participants thank you so much for the opportunity? My name is Georgia Katsalis. I'm a foster parent, trainer, and recruiter for the safe-haven program at Lutheran Social Services of New York. I work with a program that helps children who cross the border provide transitional foster parenting to set them up in the home by foster parents until they're able to reunite with their families. We currently need people who are bilingual in Spanish and English or English and Dari or Pashto or Farsi. The children are between the ages of zero, so from infants to the age of 14, and it's a voluntary program where you know we are accepting volunteers from the community. But we provide a stipend to help and close the children who stay with them for a short-term basis. It could range from a few weeks to a few months. We don't know the exact amount of time and if anyone has any information they would like to request, you can reach me at 917-684-8861.

#### • Department of Aging by Jeanette Reed

Reports: Good evening; my name is Jeanette Reid. The Department for the Aging senior employment unit. I'm here to share the good news. We are actively recruiting older unemployed Bronx residents to apply to our senior employment program. This is a shortterm paid workforce program. We offer job placement assistance and skills training to help people transition back into employment. Candidates must be unemployed, aged 55 or older, have limited income, and desire to work. The highlight of the program is they get paid to search for work. They get paid a stipend of minimum wage of \$15 an hour for 15 to 20 hours per week. At the same time, they are prepared to go to work while we are working to find an employer while helping them with their interviewing skills in their resumes. After applying to our program, the participants go through a panel interview session to assess their income and whether they qualify for the program. Once they're entitled, they start our training and the job coaching. We work with employers to match their skills to whatever job opportunities there are, so we need your help in spreading the word to the community and even people you know, relatives, or friends' neighbors who are over 55 looking to work. Many people were finding that retired and the pension or whatever they're living on is just not on their budget. And there's a lot of people that are displaced and unemployed. Our office is not open to the public, but people can call the office and ask for an application, and I will forward a brochure to the organizer. New York City Department for the Aging is a direct service. You can reach me at 212 602-6958.

- Report: Good Evening, everyone. For folks who maybe had not been eligible due to immigration status for things like unemployment. The application has closed, but it's still being processed. Suppose you have applied and haven't heard back or had any issues feel free to contact our office. We are still doing the Emergency Rental Assistance Program, often known as ERAP, which helps folks with rental arrears or utility arrears that happened during the pandemic. If you would like assistance with that, again, please come to our office. Our office is open for a bit of time at this point. We are not accepting walkins, but please call us to make an appointment. We are open physically from Monday through Thursday. The senator has been welcoming seniors back to their senior centers. For those who weren't aware, the senior centers were closed for several months due to COVID. He is happy to welcome them back. I've had the privilege to accompany the senator to a couple of senior centers with him, one of them being the guest's neighborhood Senior Center and bringing some goodie bags. That has been a lot of funthis past weekend. The Senator attended a Breast Cancer Awareness Walk hosted by Linda Kemp. The Senator was happy to coordinate a mammogram screening bus at St. Barnabas hospital. And the Senator has also been door-knocking to talk to constituents about the emergency rental assistance program. Um, lastly but not least, we will have a representative from the comptroller's office coming to our office on November 15, from 11 am to 4 pm. They're going to be helping folks with funds, which is money that has been left unclaimed with a corporation that holds those funds, and they're going to be there to help folks. You know, get that money back. To get unclaimed funds from the city or the state, please come to our office on November 15; we have two representatives who will help you recover those funds.
- Honorable Jose Marco Serrano, New York State Senator District #29
- Representative is Terrell Brooke
- Report: My name is Terrell Brock, and I'm a community liaison from a state senator positions office. Senator Serrano joined his colleagues in the legislature and a letter to Senator Schumer and the New York congressional delegation requesting an extension to all federal unemployment insurance. And we're still encouraging tenants to apply to New York State's COVID rental assistance program. You can use the link on our website, and feel free to reach out to our office to help with your application. On September 21, Senator Serrano received a perfect score on the New York League of Conservation Voters 2021 state legislative scorecard for his voting record on environmental issues. During the last legislative session, the New York State Senate passed several environmental justice bills, including one to create an ecological Bill of Rights to protect communities that have been overburdened by pollution. The proposed amendment to Article One of the New York Constitution would establish the right of each person to

clean air and water and a healthful environment, and it will be on your ballot in November. On September 27, Senator Serrano joined Senator Chuck Schumer, Congressman Jameel Bellman, Councilmember Vanessa Gibson, Bronx Borough President Ruben Diaz Jr., and Bronx District Attorney Darcel Clark at the birthplace of hip hop 1520 Sedgwick in the Bronx. We're happy to proclaim August 11 as hip-hop celebration day. In August as hip-hop recognition month and November as hip-hop history month, a presentation was made to commemorate the occasion. The Hip Hop legends Charisse, KRS one, DMC Coburg, Cindy Campbell, Leroy McCarthy, and many others are still distributing this year. ## • Committee

- Housing: Chairman Dr. Bola
- Report: The Housing Committee, there was a presentation made by the Bronx Pro group, which talked to us about the project on Grand Concourse 2017 Grand Concourse, a ninestory building. It was just an introduction because they will be going through certification by November 15. There does not require any rezoning as it is of right, but they're looking forward to moving the project along. On that project by the Bronx Pro, it's a technically small, 34 units, but 24 apartments broken down into various categories, including seven two bedrooms, 17. One bedroom and nine studios. So that's one presentation we had. We also had this second presentation, which I'm trying to build through my notes. We found that they will be coming back to give us complete, detailed updates in November, meaning it's in two phases. They've already secured funding for this one, but they will be coming back to give us more details about that. We requested an update on the pros of their project on Jerome Avenue, which is the one project they have obliged. They will give the district manager and Jerome's zoning chair a walkthrough this coming Friday.
- Parks and Recreation: Chair Griset, Medina

Report: We are trying to get Devaney Triangle ready for the planting of our new Christmas tree, which will hopefully be planted within the next week or so. Echo Triangle, we mentioned to Mr. Michael Ortiz. He will be working with the community and the Parks Committee to upgrade that park and look a little better. And the problem in that park is that we had too many homeless people in there and occupying the benches, and we were trying to clean it up and get it a little more presentable so we could have the community enjoy it as well. It's a work in progress with that, in the parks department.

• <u>Economic Development:</u> Chairman Angel Caballero

Report: We had sanitation on our call. We are trying to clean up Burnside, Jerome and Tremont in our area. Towards the Deegan, Sedgwick Avenue is within our district our with pilot projects with HRA with Jewish Community Council. We have approximately six to 10 employees coming out to help in the community. I'm very excited that the Christmas Tree will be here soon.

### • Immigration Committee: Chairperson Pooi Stewart

Report: Yes, our next meeting will be available next month on November 11, 2021. Immigration involves the diversity that we have in our community, including Haiti. So recently, on Sunday, October 17, there is breaking news in our community the Haitians kept the United States religions group; 17 missionaries kidnapped in Haiti. I would like to bring this topic the following month, November 11. And the meeting we had before we had an attorney. We're interested in doing more research on Haitian immigration. Any board member or any other residents in our community that needs help, or needs an attorney or need any assistance or advocate or anything, please get in touch with Ken. You can give Ken more information. His name is GianCarlos and is an attorney assisting on immigration. Thank you
