September 23, 2009

#### I. Welcome/Approval

- **IV.** Bernice Williams, 1<sup>st</sup> Vice Chair opened the meeting after the quorum was met.

  - Voted/elected in Martha Hunter as new Secretary for the Board

#### V. Committee Reports

- **Bronx Advisory Report** Bernice Williams, 1<sup>st</sup> Vice Chair informed the Board that only three (3) agencies came to the workshop (Neighborhood Advisory Board, Bronx Arts Ensemble, and Mt. Hope). She also reminded everyone about the Breast Cancer Walk at Orchard Beach on Oct. 18<sup>th</sup>.
- VI. Xavier Rodriguez, District Manager—informed the Board about the borough wide Budget Consultation at Fordham University on Oct. 5<sup>th</sup> and urged all Board Members to attend. He reminded everyone about the Yankee Scholarship application deadline due on Oct. 9<sup>th</sup>. He also distributed handouts on the HINI flu and said presentations will be made at schools, day care centers, and senior centers, etc. Mr. Rodriguez gave a brief report on community related activities such as hate crime incidents against people of Mexican descent. Board member Kathryn Speller requested that Mr. Rodriguez give the Board an updated report on the West Tremont Avenue and Jerome Avenue sites.

# VII. Guest Speaker, Jenny Fernandez and Mr. Chadotsang-Director of Grants & Outreach from the Landmarks Preservation Committee

- They gave an information presentation to the Board and general public indicating the Landmarks sites in CB5. Discussed necessary permits to work done on landmarks properties, certificates of appropriateness and they talked about grants for the residents.
- We have 6 landmark locations, 5 are landmark buildings, and 1 landmark-Special Historic district.

- Their main concern is preservation and compliance.
- VIII. Amendments Vote- Bernice Williams, 1<sup>st</sup> Vice Chair read the amendments, combined and added: A) Housing & Economic Development, B) Health & Human Services, C) Public Safety, Transportation & Sanitation, D) Immigration & Veteran Affairs (New Committee) E) 197-A Planning (New Committee) the purpose for the amendment was to streamline Board #5's standing Committees from 12 Committees to 9 Committees. By Laws Amendment pass Vote 11 yes 1 abstention.
- **IX. Public Session** The following members from the community expressed concerns and provided information during this session
  - Sallie Smith Resident, spoke about homes & buildings boarded up.
  - Louella Hatch Resident, said all their kids returned to school safe and she also emphasized there are all types of racial gangs. She also commented on the most recent hate crime and informed the Board it is her understanding most residents and youth feel safe throughout the local neighborhood where these incidents happened. She further stated that these incidents should be investigated as gang and drug related incidents.
  - Susan Tillman Representative of Failure Free Reading Services
     They serve the lowest readers of literacy, ESL student, and they target schools and teens. Services are free
