- Welcome by Nero Graham, Jr., 1st Vice Chair. Community was informed that the chair, Angel Caballero, is not present due to a family emergency. Mr. Graham invited the community to reach out to their local officials if they have concerns. Agenda will be modified until there is a quorum. Morris Heights Health Center has received a grant to rebuild their health center on 181st Street. Last night was the 46th precinct council meeting.

- walk-through for the new Community Reinvestment Act officer at Amalgamated Bank along Burnside Avenue on February 13th. Business owners were engaged in conversation. The needs of businesses were discussed and there is an expectation that Amalgamated Bank will deploy resources to meet the business community's needs. On March 15th there was a re-imagining the Cross-Bronx community engagement virtual session. The community will be engaged in the re-design of the Cross Bronx Expressway. There will be subsequent meetings to gather public input on the redesign. A plan should be made avaibael in approximately 1 year. There is engagement with 'Sole Wash' a program in Washington DC that washes sneakers and hosts arts programming. There are conversations leading towards opening a branch in the district.
- **46**th **Police Precinct report.** The next Precinct Council meeting will be held on April 18th. Officer Watson and Officer Postmonoivic. Yesterday was the 46 precinct community council meeting. Inspector was unavailable to come to this meeting.

• Public Session.

- Sallie Smith, resident, spoke in regards to her following concerns: There is a need for an allocated space for bus parking at the Morris Senior Center. The current stop is at the corner of 181st Street and Morris Avenue and this is a hazard. Garbage has been piling up at 2086 Valentine Avenue since Sunday. Mr. Graham said that the Department of Transportation will be asked if a stop can be accommodated
- Melissa Guzman, representing St. Barnabas Hospital. The Wellness Center is open and has services for the community. These include a Health Plex, which is open Monday-Friday, 6.30-8.30, Monday through Friday, Saturdays 9-4 and Sundays 9-2. The address is: 4507 3rd Avenue. Telephone number is: 718-960-

- 9245. There are also monthly healthy cooking classes. There is a Ramadan event on April 15th. Classes are \$5 per class. A food pantry is at the same location, first floor. Walk-ins are welcome. Every Thursday 1-4PM.
- Carrie Cuthbertson, President of Morris Bean Garden. She is concerned about the constant gunfire near the garden. This occurred as they were walking home from the 46th precinct meeting. She also distributed flyers for Spring events at the Garden.
- O James Hwang. He is the owner of the laundromat that burned down on Grand Concourse 2 weeks ago. Recited incident of the fire. He has lived in the Bronx since 8 years old. Store was owned for 15 years. Landlord has been difficult. Supermarket damaged laundromat. Con Ed rebuilt gas lines. Building was shut down. He informed Con Ed that there were other concerns. Supermarket expanded. Fire was responded quickly, within 4 minutes e-bike fire was doused. (Told that time was limited by Nero Graham and recommended that he share this with the Fire Marshal). He asked that 2 more minutes be afforded him, which was denied. Started to speak asking if he could finish. Was told that he should not do that and if he continued he would be escorted out. Mr. Wong said he would leave.
- Pilar Maschi. City Parks Foundation. The Catalyst program is for the City's most neglected parks. The next park to be added to this program is Echo Richmond Park.
- Odette Wilkins. Presented concerns about 5G towers. Bronx CB 5 is slated to have 20 Link 5G towers installed. 7 of these are scheduled for construction. The comment period ended on March 4, 2023. An extension for comments would have to be requested to the Office of Technology and Innovation. Ms. Williams asked that she present to the Municipal Services' committee in May.

 Support for the Jenny Jones playground redesign. \$4.3 million allocated for project.

Vandalism and noise are concerns. (This was interrupted as Mr. Wong returned. He was told by Mr. Graham to leave. Board members said that this ejection was inappropriate). Only concern was about crossing the street to get to the park on both the Jerome Avenue and Cross-Bronx sides of the park. A safety barrier was proposed to the Department of Transportation by Parks to see if this can be mitigated. A self-closing gate was recommended.
