 - Quality of Life- Expressed significant disappointment that the flower beds on the Grand Concourse are being used as trash bins.
 - She would like to hear an update by the next community board meeting she attends (in June)
 - Quality of Life- Is upset about the mobile car washes that continue to pop up in the community. They use municipal water and she does not know whether they pay to do so.
 - Transportation and Municipal Affairs- The bus stop on the Grand Concourse and Burnside is still missing. This means that she and other seniors often have to walk steep hills or use the underpass.
 - Municipal chair Lucia: At the last Municipal Services committee meeting mentioned that it may likely not return as it was not an original bus stop on that line.
