**ii. A vote was taken, and the motion passed with 4 votes in favor, 0 nays, 0 abstentions, and 1 absent.**

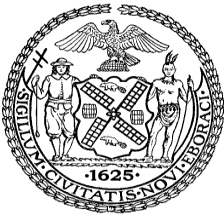
