### Bronx CB 7 MOTION SUMMARY

#### January 14, 2020

Title: Letter of support for tenants of 3425 Gates Place | Motion #: Housing-1

Committee(s): Housing, Land Use, & Economic Development

Recommended Action: Draft and send a letter to the New York State Division of Housing and Community Renewal (DHCR):

- 1) Urging DHCR to reduce or eliminate the Major Capital Improvement (MCI) charges assed to tenants of 3425 Gates Place, which dispute was apparently exacerbated by a language barrier and lack of notice, or alternatively, to seek a negotiated solution between the landlord and tenants; and,
- 2) Urging DHCR to require that all leases and other important documents be offered in languages other than English.

Background: Tenants of 3425 Gates Place object to the imposition of \$81.33/room/month MCI charge. The tenants allege the landlord provided insufficient or misleading notice about the MCI and that the landlord's representatives have harassed tenants. They further allege that the MCI work was unnecessary and that the renovations have actually contributed to the deterioration of their apartments. In response to this dispute, 25 of 52 tenants are withholding payment of their MCI charges or rent. The tenants are working with Northwest Bronx Community & Clergy Coalition and their elected officials to challenge the MCI charges, seek redress from the landlord, and bring attention to this mater.

Rationale for Recommendation: The committee is empathic to the tenants concerns about their living conditions and the process by which their landlord imposed the MCI charges. While the time has passed in which the tenants could legally challenge the MCI charges, the committee nonetheless urges DHCR to find a solution to this dispute. The committee also urges DHCR to require that leases and other important documents be provided in languages other than English. The committee believes this may be a global solution to the inadequate or insufficient notice issue that gave rise to the dispute at 3425 Gates Place.

<u>Title</u>: Follow-up on a Capital Project | Motion #: Parks-1

Committee(s): Parks'/Recreation/Cultural Affairs

<u>Recommended Action</u>: A letter be sent to Parks' Commissioner Rodriquez requesting the status of the replacement of the heating system at the Mosholu Parkway Comfort Station, which is now referred to as the Webster House. The letter will mention the many delays to this project.

Background: The project was supposed to start in 2013 and was due to be completed in 2016. To date nothing has been done.

Rationale for Recommendation: The project was paired with the replacement of the heating system at the Bensonhurst Senior Recreation Center. We want to make sure the funds do not get transferred to this other project due to cost over-runs.

<u>Timing</u>: Procurement was supposed to be completed in November 2019. It has now been delayed again.

<u>Prior Action</u>: The committee has checked on the progress of this project with the Parks' District Manager and also checks the Capital Project Tracker on the Parks' website.

<u>Future Actions</u>: Discuss future actions with the Parks' Committee e.g. article in press, Channel 12 or an additional letter to the NYC Parks' Commissioner.

- b) <u>DHS</u>- The Journey Home an action plan to End Long-Term Street Homelessness. DHS/HRA objective is to have 1000 new transitional Safe Haven beds and 1000 new low-barrier permanent housing units, they are asking for help from every community to identify locations.

    - Non-profit: Highland
    - 90 Units of which 45 will be for permanent housing.
- c) <u>HRA</u>-The New York State DMV is now accepting applications for driver's licenses from all New Yorkers, regardless of immigration status! Now any New Yorker, 16 and above, can apply for a standard, not for federal purpose, non-commercial driver's license or learner permit, regardless of immigration status. All applicants must provide 6 points worth of documents that prove identity, and also prove date of birth and residency. IDNYC can be used as 1 point of proof of identity and also counts as proof of residency. If you have never been issued a Social Security Number, you must sign an affidavit stating that and bring it with you when you apply.

- d) DSNY-On March 1, 2020, New York State's law banning single-use plastic carryout bags takes effect. In New York City, businesses will also be required to collect a 5-cent fee on paper carryout bags from customers. The ban and fee are efforts to reduce the use of wasteful single-use bags and their negative

impact on the environment. If you pay using SNAP or WIC, you will not be charged any paper bag fees. Stores must provide SNAP and WIC users with free carryout bags. No other customers are exempt from this fee. You can avoid paying the fee by bringing your own reusable bags to stores. Stores are required to sell reusable bags for customers.

- 1) I will be working on supermarket parentships to provide bags. The Environment and Sanitation Committee will be working on this as well. Please review calendar for their next meeting.

The CPC may, by authorization, allow an increase in the maximum building height, up to 15 feet, to accommodate the additional floor area.
    - This development will be further discussed at a later housing meeting as they will be seeking a letter of support.
- f) Bronx Bus Redesign Update: A letter of concern and objection was sent to the MTA along with all the petitions submitted by residents opposing the changes. I have worked closely with NYS Senators Gustavo Rivera's office to plan a Town Hall inviting the MTA to address the Bronx Bus Redesign Concerns in our district on Saturday, February 1<sup>st</sup>, 2020.

  - a) Project Renewal Update: Bedford Green House, 2865 Creston Avenue
    - 1) Mr. Paul Woody stated that the construction of Bedford Green House has topped out and that the building was mostly enclosed. However, the project's general contractor recently filed for bankruptcy. A new general contractor is in place but the project will likely be delayed as a result. Likewise, phase two of the project is also delayed.
    - 2) Mr. Woody stated that the facilities on the roof of the building are secure and are not at risk of coming loose from the roof. He explained that a greenhouse and aquaponics facility on the roof would supply produce for building residents. He stated Project Renewal received more than 40,000 applications for apartments in the building and that CB 7 had assisted prospective tenants prepare their applications. He stated that that the City closely monitors the lottery process to ensure that the building meets its targets for area residents. He stated that 40% of units are set aside for residents earning up to 60% of AMI while the remainder of the units are set aside for supportive housing.

He explained that Project Renewal was now hiring staff to operate the building.

- b) Discussion with Northwest Bronx Community & Clergy Coalition (NWBCCC)
  - 1) Three tenants and a NWBCCC representative spoke about issues with Major Capital Improvements (MCI) charges at 3425 Gates Place. The tenants recounted how in early 2019, their landlord began a construction project to modify kitchens and bathrooms in the building. As a result of the construction, the tenants lived without light, heat, kitchens or bathrooms during January 2019. Some tenants could not understand why their landlord was doing construction as their kitchens and bathrooms were newly renovated or otherwise adequate. Since construction finished, tenants noted that the renovations were falling apart and there are plumbing problems. Tenants objected to the lack of notice about the construction; when the landlord did provide notice, it did so in English while the majority of tenants speak Spanish. The tenants strenuously objected to the MCI charge of \$81.33/room (\$243.99/month for a one-bedroom unit and \$325.32 for a two-bedroom unit). To protest the MCI charge, about 25 of 62 tenants are withholding their MCI charges or rent payments.
  - 2) The tenants objected to either insufficient or misleading notice about the construction and resulting MCI charges. The tenants stated that some units received notices about tax abatement but not about the MCI construction. Many tenants reported harassment by the landlord's representatives, who would repeatedly knock on their door and pressure the tenants to sign documents they did not understand. As a result, the landlord has brought eviction proceedings against several of the tenants. The tenants asked the Committee to support them at their upcoming February 5 housing court appearance. Through their elected officials (Senator Bailey, Assembly Member

- DACA (Dream Act) addresses children who come to the US with families with the intention of staying. On June 2020, a final decision will be made about DACA. People can still apply for DACA in order to stay in US. Governor Cuomo passed New York State version of DACA where those under DACA can become eligible for financial aid through CUNY/SUNY and access legal services through the Dream Fund.
- Green Light Driver's License allows people to apply for license regardless of immigration status. If denied, person can retain a lawyer for assistance and report incident to NYIC. Common fear is safety of applicant information, but individuals cannot unilaterally pull up information for the purpose of finding undocumented individuals. There is no citizen questions on the application.
- NYIC is working on a "hate crime community toolkit."
- Common question is why should undocumented person participate in the census. All should participate because failure to filling out the forms can have a negative affect on community. Census can be completed online, so that people do not feel intimidated from having to open the door to encounter ICE agents who commonly target people at home).
- Public Charge rule is used on certain applicants. Anyone applying for a green card or a visa would be a public charge if receiving SSI benefits. Anyone seeking asylum or is a victim of domestic violation will not be affected by public charge rule.

- Medicaid, SNAP, Section 8 was in danger of being part of the public charge rule, but lawsuits prevented this.
- Individuals can call New Americans Hotline at 800-566-7636 if they have questions or need legal advice. Multiple languages are available, and callers can be anonymous.

#### 2) Immigration and Customs Enforcement

- Who is at risk of being picked up: those who are removable under immigration law, those without lawful status, and those with lawful immigration status with criminal background.
   Agents are not allowed to pick up people at schools, hospitals, places of worship, courthouse or any sanctuary places. Agents cannot enter or walk into private areas or areas with privacy signage.
- If you witnessed a raid, document and record where and when it took place, how agents presented themselves, what was said, what intimidation tactics were used, and was consent given to enter or search.
- Individuals can call Immigrant Defense Project (IDP) at 212-725-6422.
- ICE can try to coerce individuals to get permission to enter home by saying they are looking for a suspect, need help with a criminal investigation, need to talk to you about a criminal issue, or need to search your car because there was a robbery.

#### 3) What You Can Do?

When you encounter an agent, you can ask for an ID and a warrant, but the warrant must be issued by a judge and cannot have misspellings on name and address. You can refuse entry into your home and search of your car, belongings or self. You can refuse to provide information on your immigration status or criminal history.

You can talk to a lawyer and ask to call your emergency contact and/or your consulate.

- During an ICE arrest on the street, you can ask if you are free to go and refuse permission to search, but DO NOT give foreign documents or false documents. This is a felony that gives the agent a reason to detain you.
- During an ICE arrest at work, ICE can enter the workplace with permission from the employer or a valid warrant. It is advised that you do not run, but you should make a plan with co-workers and make sure everyone knows the plan and their rights. It is a good practice to have at least one workplace representative onsite who can deal with issues pertaining to ICE.
- Making a plan is important. In order to be prepared, it is advised that you find a lawyer who can help, memorize phone numbers and alien numbers, safeguard important documents, have a family safety and child care plan, save money for emergencies, get help from the consulate and talk to a family law lawyer
- The child care plan is important because parents who get detained often get separated from their children and children end up in foster care
