Title:

Letter of concern regarding Care for the Homeless

Committee(s): Housing, Land Use & Zoning

Recommended Action: Draft and send a letter to elected officials and city and state agencies regarding Care for the Homeless' proposed medical clinic at Bronx Works' 3600 Jerome Avenue shelter, recommending that: 1) the medical clinic should only serve shelter clients residing at this facility; and, 2) oversight agencies should thoroughly examine data to identify needs and refrain from licensing facilities in communities where adequate services already exist.

Background: Care for the Homeless proposes to open a medical clinic at Bronx Works' 200-bed shelter at 3600 Jerome Avenue. The shelter currently serves a population of men with mental illness. Care for the Homeless has applied for an Article 28 license to operate the clinic from the State Department of Health. Based on the Care for the Homeless' other clinics, this clinic may service shelter residents and non-residents.

Rationale for Recommendation: The committee is concerned about the concentration of service providers at this location, which is adjacent to a school, as well as that this facility would duplicate services already available. The Committee is also concerned that service providers are not forthcoming with data documenting the actual need for services in this community as opposed to the City in general. Likewise, the committee recommends that licensing authorities thoroughly examine the need for these services and whether existing service providers have the capacity to adequately provide these services. Finally, the committee is concerned that Care for the Homeless' clinic would eventually serve a large number of patients who are not shelter residents.

 - At Clinton High School on November 20, 2019 a male 16 years of age was stabbed, requiring seven stitches not life threating. Extra officers have been dispatched around Clinton High school. Officers from both 50 and 52nd pct. will be visible. There will also be additional school safety agents within the school grounds and transit officers near the train.

 - In August 2019, the federal government announced a new rule related to when certain immigrants might be considered a "public charge" under immigration law. It could prevent some immigrants from getting legal permanent residence status (also known as a green card) or a visa if they use certain public benefits or the federal government believes they are likely to depend on public benefits in the future. A court has blocked the rule from going into effect for now. On Friday, October 11th, a federal judge granted a nationwide preliminary injunction in a lawsuit brought by New York City, the New York State Attorney General's Office, and the States of Connecticut and Vermont. This means the public charge rule is blocked from going into effect for now.



 - a) Presentation from Washington Greys Military Cadets
 - 1. The comandante of the Washington Grey Military Cadets offered an overview of the organization. The Greys have been based at the Kingsbridge Armory since their inception in 1952. The Greys were founded as a military band and later re-organized as a Corps of Cadets and most recently as a high adventure group. In 2017, the New York State Division of Military and Naval Affairs (DMNA) asked the Greys to stop drilling at the Kingsbridge Armory Annex Building because of environmental issues in the Annex. Without the Annex, the Greys use PS 86 and Fort **Independence Community Center.**

- Recently, DMNA offered the Greys a lease to use the Annex again. 2. However, the Greys previously used the Annex for free. The rent offered by DMNA is prohibitively expensive. According to the comandante, Military Law §183 provides that a municipality can ask DMNA not to charge rent to certain qualifying organizations to use an armory building. Therefore, the Greys asked for a letter from CB7 to DMNA supporting the Greys' use of the Kingsbridge Armory Annex Building rent free.
 - Motion: CB 7 will send a letter of support to DMNA to permit the Washington Greys Military Cadets to use the Kingsbridge Armory at no charge for rent and security per Military Law §183. Approved unanimously with one abstention (K. Davis).

District Manager's update IV.

- a) Ms. Bravo discussed a stabbing outside DeWitt Clinton High School on November 20. Officer Reveron will be at the Nov. 26 General Board Meeting to answer questions about the incident.
 - 1. She explained that CB7 staff was testing a new Department of City Planning portal called ZAP, which tracks ULURP and other land use actions. The link will be shared in the future.
 - 2. She explained that the MTA's Bronx Bus Redesign would have multiple impacts in the community. The most notable impacts are a reduction in Express Bus service and re-routing of the Bx34 bus away from Valentine Ave & Bainbridge Ave, which would impact seniors living at Serviam Gardens.
 - 3. Finally, she raised the issue of Fokkus Restaurant on West Fordham Road & Loring Avenue using a pedestrian ramp to access it parking lot. She planned to raise the issue with the appropriate City agencies.

Finally, Mr. Martinez proposed to create an ad hoc Census Committee in support of the 2020 Census, noting the importance of an accurate count to the community's representation and allocation of grant aid.

 - 1. Mr. Laiosa stated that the committee plans to meet on November 25 and December 9.

She also mentioned a request for trash cans on 205th Street, the availability of brown bags for leaf collection, and the availability of the organics recycling program. - 1. Mr. Karman explained that George Neshak, Executive Director, Care for the Homeless (CH) presented at the November committee meeting. CH is in the process of opening a medical clinic at Bronx Works' 3600 Jerome Avenue shelter for men with mental illness. Ms. Bravo explained that Bronx Works never mentioned the medical clinic when it first presented the shelter to the Board. She emphasized the community's concern about the concentration of similar facilities, the proximity of a dance school to the shelter, and the potential for the shelter and clinic to attract a population from outside the neighborhood.
 - Motion: CB 7 will send a letter to elected officials as well as city and state agencies recommending that Care of the Homeless' proposed medical facility at Bronx Works'3600 Jerome Avenue mens shelter should: 1) only service shelter clients residing at this facility; and,) oversight agencies should thoroughly examine data to identify needs and limit licensing facilities in community where adequate service providers already exists. The motion passed unanimously.
- f) Parks, Recreation & Cultural Affairs
 - 1. Ms. Stronczer stated that the committee discussed a request by a group to create a community garden on Davison Avenue near Monroe College as well as the committee's appreciation for the work of the Parks Department's gardeners at Williamsbridge Oval and Mosholu Parkway. She stated the annual tree lighting would be December 12 on Mosholu Parkway & Bainbridge Avenue.
 - Motion: The Parks' Committee recommends a letter of support be sent to Commissioner Rosa regarding the proposal to create an urban garden at 2502 Davison Ave.

60 Sanitation police officers with arrest powers and a contingent of enforcement agents are deployed daily throughout the five boroughs, educating property owners as well as issuing summonses for dirty sidewalks & other infractions of the Sanitation codes. Some members asked that the DSNY implement an enforcement blitz – going out on a given week and issuing summonses to send the message about the importance of maintaining clean streets.

- A discussion ensued on what CB 7, in conjunction with DSNY, can do to educate property owners about their responsibility to keep sidewalks and gutters clean. The committee is considering a campaign, perhaps in conjunction with community groups and organization, as well as other community boards to highlight the impress upon community residents the importance of keeping our neighborhoods clean.
- 2. Update on maintenance along Parkside Place efforts by community residents resulted in a major clean up of Parkside Place but it was evident that DSNY will not be able to conduct even periodic maintenance of this area.
- 3. Recycling a lively and informative discussion on what is recyclable and what is not. Flyers are available in the CB office.

 - a) CFH Health Center located at 3600 Jerome Avenue
 - 1. Mr. Neshak presented an overview of the facility that Care for the Homeless planned to open at Bronx Works' Jerome Men's Shelter at 3600 Jerome Avenue. He explained that Bronx Works asked Care for the Homeless to provide federally approved medical care services at the shelter. The facility would operate under a sub-contract between the City and Bronx Works. Once the facility obtains Article 28 approval from the State Department of Health, it will become a full-service health center. Mr. Neshak noted that Care for the Homeless operates a similar medical facility at Susan's Place, 1921 Jerome Avenue.
 - 2. The Committee expressed safety concerns about the site and noted that Department of Homeless Services (DHS) began providing police services on October 1.

Mr. Neshak noted the 30-year relationship between Care for the Homeless and Bronx Works. Mr. Neshak stated that the facility would only see patients by appointment. Mr. Neshak explained that Cares for the Homeless obtained a letter of support for their application from Montefiore, which noted the congestion in its emergency room. Mr. Neshak stated that the facility was not a substance abuse service provider and no drugs would be dispensed at this facility. In response to questioning from Assembly Member Dinowitz, Mr. Neshak stated the health providers at 3600 Jerome Avenue would probably refer patients to its facility at 1921 Jerome Avenue for Suboxone. He stated further that there was a 50-50 split between clinic residents and non-residents at the 1921 Jerome Avenue facility.

3. The District Manager expressed community concern about the concentration of drug treatment services in the vicinity of the planned facility. Mr. Neshak responded that he believed on site services for homeless residents offer a lower barrier to use those services than do off-site services. In response to a question about why this site was chosen, Mr. Neshak stated that his organization was attracted by the presence of the shelter and support from Montefiore. Mr. Neshak stated that his organization reviewed the Community Health Assessment and stated that there was overwhelming demand for clinics in the area but could not cite any sources. He stated that the facility would be staffed by two physicians (less than full-time), two-to-three nurses and interns, and support staff. The committee expressed its concerns that patients would be referred to this facility from outside community district 7. Mr. Neshak stated that the state licensure

enables the facility to accept Medicaid funding and that a federal government grant covers an additional portion of the facility's operating budget.

4. The committee chairperson made a motion to draft a letter to elected officials and City agencies that: 1) Care for the Homeless' facility at 3600 Jerome Avenue only service the clients residing at the shelter; and, 2) city and state agencies thoroughly examine data to identify needs by community and to limit licensing facilities when there is not a need.

 - 1. The committee discussed the matter of Stagg and Five Stars. The governor recently directed an investigation of Stagg and Five Star buildings after tenants raised concerns about conditions in the buildings. Ms. James stated that the Northwest Bronx Community & Clergy Coalition (NWBCCC) was working to organize tenants in the buildings and substantiate their complaints. She stated that the investigation was being led by DHCR with HPD. - 3. Programs for caregivers are free of charge.
- 4. The program provides a free bracelet to Alzheimer patients with their information so that they can be easily identified and returned to their family in case they wander away from their home.
- 5. The staff works closely with other City Agencies like the NYPD and the FDNY whose members are educated to look for the bracelets on the patients to assist them in a timely manner. The program covers all five boroughs and will assist people in boroughs outside of NYC with guidance and referrals. For more information call 646-744-2900 or go to the website: www.caringkindnyc.org
- b) Officer Pacella reported on the Transit Division crime statistics and robberies are up in the last 28 day period.
 - 1. On the #4 train stations at Mosholu, Kingsbridge, and Woodlawn specifically the robberies have been happening regularly. Mostly "lush crime" meaning people that fall asleep on the trains (whether because they are tired or intoxicated). Sometimes they may be robbed at another station, but the crime is reported when they wake up at a station that happens to be in the 52nd Precinct area and this has a negative effect on the precinct's statistics. A 17 year old was apprehended for some of these "lush crimes." Overall in the 52nd Precinct in the last 28 day period robberies are up.
 - 2. The one crime that has gone up is the e-bikes robberies. The precinct has made it a point of approaching the Chinese businesses to assure them that the officers are working on

reducing the e-bikes robberies. The precinct made the rounds with a Chinese officer and the business owners felt confident speaking in their own language to the officer, which builds trust between the business owners and the NYPD.  - 1. New York Health Act is currently being promoted in a way to get support of elected officials to pass into law
 - 2. Goal of NYC Care Health Plan is to educate as many people as possible and collect as many stories as possible from those who navigate the system for enrollment, and this is based on how we can get everyone health care in a dignified way.
 - 3. NYC Care is designed to serve those without access to healthcare, those who make a little more money than those who qualify for Medicaid, those who are undocumented, small business owners and independent contractor.
 - 4. Currently rolled out in Bronx with 7000 enrollments to date, with future expansion to Brooklyn in January
 - 5. Northwest Bronx Clergy Coalition at 103 East 196th Street serves as a direct enrollment site on Fridays from 10 am to 12 pm.

- 6. Anyone can call 1-646-NYC-CARE and reach a financial counsellor within 2 days and possibly be scheduled with a primary physician in about a week.
- b) Legislation 1662 Regarding Workplace Lactation Rooms-Christine Lebron-Reyes
 - 1. Under Affordable Care Act, provisions were made for employees who require lactation accommodation
 - 2. If bill is passed, there will be regulation of cleanliness and maintenance of designated spaces with quarterly inspections from the Department of Health (employers will be held accountable)
 - 3. 25% of infants in USA were exclusively breastfed through 6 months, with transition of mothers going back to work being a major reason
 - 4. Referencing amended section 7 of Fair Labor Standards Act, employers are required to provide break times for women who express milk and a functional space that is not a restroom
 - 5. Currently, nothing in Federal law mandates securing of and cleanly maintenance standards of designated lactation space.
 - 6. 25% of women in Bronx have stated willingness to breastfeed, while other boroughs average near 38%
 - Motion: For CB7 to write a letter of support for City Council to pass Legislation 1662 to ensure private, clean, safe and accessible environment for employees who require lactation accommodation. Motioned by Gloria Bent, seconded by Cristina Contreras. 3 yay, 0 nay, 0 abstentions. Motion passes.
