#### I. Introductions

a. Jean Hill opened the meeting at 6:40 pm with a "Thank you" to the Scott Tower Board for their hospitality in hosting the CB 7 General Board Meeting.

#### II. Elected Officials/Public Session

- a. Councilman Fernando Cabrera gave an update on the Jerome Avenue zoning including the award of 9 million dollars for construction of PS 246 which was built in 1916.
  - 1. He also cited the OTPS funds that each CB received for additional resources. He is encouraging the CB members to write letters to the Mayor to continue the funding as a permanent line item.
  - 2. The Councilman announced the passing of the Early Voting bill with 7 sites. He is urging the opening of more sites.
- b. Maximo Javier, representing Congressman Adriano Espaillat reported that their office at 2530 Grand Concourse is open for the next 2 months.
  - 1. There will be a 2020 Census Town Hall on May 23<sup>rd</sup> from 6 8 pm at Serviam Hall. All are invited for the latest updates and for information on job offerings.
- c. Josephine Cristostomo, from the Mayor's office reported on the funding of the Crime Victims Assistance Program to be located in local police precincts. There will be 2 Advocates who will provide resources for victims. NYC will have a hot line for those in need of counseling.

  - 1. Bill INT-1251 is a bill with the goal to reduce Green House Gases. This legislation will help reduce energy use and improve air quality.
  - 2. Bill INT-1301 is a bill requiring the NYC Department of Education to create an on-line portal to facilitate the comparison of funding and spending across schools.
  - 3. Other issues being addressed are the Tenant Protection Law and the Bus Stops Countdown.

- m. Dilletta Pina reported on the Early Voting bill that was passed in Albany. At present, there are only 7 sites identified for early voting. It is expected a huge increase by 2020 to accommodate more voters.
  - 1. Dilletta presented an award to Michael Rosario for his assistance in a recent event held by the Committee. He received a great round of applause from all especially Board members who have called on Michael in the past.
- n. Councilman Andy Cohen reported on the Preliminary Budget and shared a proposal of 40 million dollars for a proposed new 52<sup>nd</sup> Precinct Annex that may be located in Sam's Carpet store.
  - 1. He is still working on the 5 million to be assigned to Frisch Field for upgrades. Continued funding for Senior Citizens Program remains a priority for the Councilman who is greatly concerned if there is a mention of less funding.
- o. Amy Tsai, who serves on the DOE District Council, spoke about the need for a High School for children with IEPs who live in the community. She is appealing to the community to support the effort of constructing a separate school for children with special needs.

  - 1. Environment & Sanitation Committee: To support the Waterfront Edge Design Guidelines Standard for New York City.
    - Motion approved unanimously
  - 2. Resolution; Waterfront Edge Design Guidelines (WEDG)
    - WHEREAS, sea levels are rising across the globe, and will continue to increase the extent, frequency, and duration of storms and coastal flooding. These risks come with increasing costs, both event-based and day to day. Hurricane Sandy has cost New York City \$19 billion to date<sup>1</sup>, and flood insurance rates continue to rise<sup>2</sup>; and
    - WHEREAS, by 2050, NYC's average temperature is expected to rise between 4.1 and 6.6°F, and annual precipitation is expected to increase between 4% and 13%, which could exacerbate flooding<sup>3</sup>; and
    - WHEREAS, despite these rapidly increasing risks and costs, new waterfront development is occurring at a rapid pace. Over 400,000 New Yorkers have a 50% chance of experiencing a major flood in their homes by 2060, and over 41% of those are economically and socially vulnerable<sup>4</sup>. And, increasing density in neighborhoods across the Bronx calls for smart choices about how we prepare for storms through design and management of developments in the floodplain; and
    - WHEREAS, the Waterfront Alliance has a tool, the Waterfront Edge Design Guidelines (WEDG®), which can equip Community

Boards to make more informed decisions on smart design, coastal resiliency, and improved access to the waterfront; and

- WHEREAS, WEDG is a nationally recognized standard to enhance resilience, ecology, and access in waterfront development. Any waterfront project which touches the waterfront edge – residential, industrial, mixed use or park, is eligible for WEDG certification. There are eight WEDG Certified projects in New York City including Starlight Park and Oak Point/ McInnis Cement in the Bronx; and
- WHEREAS, WEDG is a toolkit that empowers communities, builders, and decision-makers to consider factors such as hard infrastructure, green infrastructure, ecology, best practices in design and waterfront access options including kayaking, walkways, parks, waterborne transit (ferries) so that the whole community benefits; and
- WHEREAS, WEDG is a powerful, simple, and freely available communications tool, and grassroots movement to empower communities to protect their homes and build stronger, more equitable and resilient neighborhoods. From the Bronx to the south shore of Staten Island, WEDG has already made a strong impact on improving waterfront communities, and the movement is growing; and
- WHEREAS, as Community Boards are on the forefront of reviewing major projects and reshaping local waterfronts,
   Waterfront Edge Design Guidelines can help hold developers to a higher standard, improve land use decisions, and help citizens advocate for a more equitable development process. Community Boards can make commitment to creating more resilient, equitable waterfront development in their districts by adopting a resolution encouraging the use of WEDG for all waterfront projects.
- THEREFORE, BE IT RESOLVED THAT Bronx Community
  Board 7 encourages all waterfront projects in the Bronx Community

Park crews have been working numerous shifts to clean the area. Ms. Maschi is planning the next meeting concerning Aqueduct Park on Thursday, April 18<sup>th</sup> from 6:00-8:00PM. The meeting will take place at St. James Recreation Center. It is hoped to have a "Friends of Aqueduct" established in the near future. Ms. Maschi also hopes to be able to develop a similar group for Devoe Park.
- e) Signage: A request to have the "No Barbecuing" signs installed in district parks by Memorial Day was made. Mr. Magneri will try to accommodate this request. He also stated that new signs listing activities not permitted in certain parks would be available in the fall.
