- -Crime Prevention
 - ✓ there has been rise on elderly assault please let community know to be vigilante
 - ✓ Halloween is coming up please review treats and avoid children going out alone
 - ✓ Additional safety tips will be posted to twitter and please reach to officer Acosta at NYPD 52nd Precinct
- Attempted bank robbery at 204th street and Perry Avenue was unsuccessful
- -Some members of the public are very upset about people shooting up heroin in public: the process is to submit the complaint to 311 (NYPD will now be reaching out Project Hope for support)
- -203rd/204th Street on Valentine Avenue "Green House" issue with group of guys: NYPD has done search warrants and narcotics team have arrested a person with active case. NCO Cepeda and Fernandez from Sector C will be testifying on the case in landlord tenant housing court to evict people from house – with the hope to legally remove them from that place
- -Concern about safety problem on Mosholu parkway with overflow of the parking lot for NYPD 52nd Precinct: District Manager summarized/gave background to public about what CB7 has done for this request such as previous work on making precinct larger and fixing parking space for NYPD 52nd Precinct. NYPD is aware and works with supervisors to make sure to cars are moved as officers have no space to park

- The committee dispensed with all other items on the original agenda because guest speakers were not available and allow the committee the opportunity to discuss the CB 7 Budget Request priorities.
 - o Sanitation and Environmental Issues
 - Committee agreed to retain all items currently in budget request
 - Additional items to be added are under consideration:
 - Request funding to retrofit hydrants so that only authorized personnel can open as needed. Currently hydrants can be opened at will by anyone with the appropriate tool, allowing for thousands of gallons of water to be wasted.
 - Funding to educate the community on helping controlling/eliminate the rat population by addressing poor or inadequate sanitation and garbage storage practices in our neighborhoods. An ongoing rat control/elimination program is necessary due to the increase in rat population. Similar to a free program offered by the City a few years ago for building supers and homeowners.
