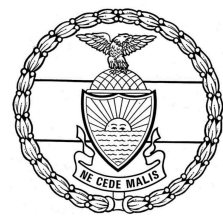

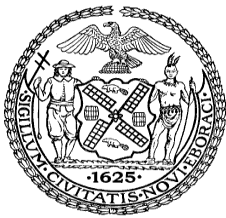

Bureau Vision Zero Enforcement Unit. Working on East and West Fordham Road, Broadway, and Grand Concourse. February 21st through March 6th. Combining both education and enforcement of traffic laws teaching both drivers and pedestrian. 400 B summonses and 142 criminal court tickets, criminal court tickets for commercial vehicles. Questions about not ticketing of parked cars illegally parked at a hydrant. Question about trucks being parked on many streets. Question about loud exhaust on Bailey Avenue. Question on the E-Bikes being used on sidewalks illegally, enforcement on selling and riding of E-Bikes inappropriately with education on proper usage. Questions on hydrants and blocked crosswalks throughout the precinct.

- PO Benedith from NYPD Transit District 11 April 15th will have a safety event on 161st Street near the precinct. Addition of precinct officers has helped with the situations at stations. Questions on panhandling and how 311 will not assist with transit issues. Safety concerns at the Bedford Park train station and D Line.
