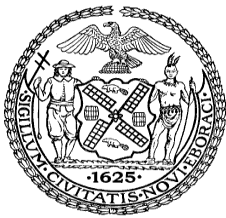

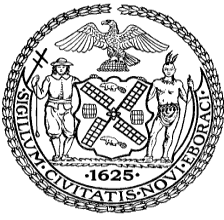

- 1. TD11 Neighborhood Coordination Officer (NCO). NCO Admin P.O. Geraldine Diaz, P.O. Richard Acevedo, P.O. Marcus Minott, P.O. Olivero, P.O. Caceres answers questions and give updates on crimes on the subways and in the CB7 neighborhood
 - a) Discussion on school safety teams that include officers who patrol schools at dismissal time to deter violence.
