A. DWCP about commercial issues

- 1. CB7 staff communicated the concerns from the community about several businesses that have over extended their products to the sidewalk and beyond. DWCP will visit a few of the businesses provided by the staff and that hold licenses with the agency, but stated that regulating and enforcing the occupation of the sidewalk with commercial products fall under the jurisdiction of the NYPD and DSNY.
