COMMUNITY BOARD MEETING MINUTES

Tuesday, February 17, 2009 @ 6:30 PM

Bronx Library Center, 310 E. Kingsbridge Road, Bronx, NY 10458

- I) Public Session began at 6:30 PM
 - A) Jeff Dinowitz Assemblyman:
 - 1) Remarked regarding the MTA's plan for fare raises, discontinuance of some bus lines and increased "Access-A-Ride" fares
 - 2) Spoke on the new housing bills that were introduced in the state assembly that would protect tenants rights
 - B) Henry Perry Community Resident:
 - 1) Expressed concerns regarding the new homeless shelter that has been proposed in the community and that has opened at his building located at 15-19 West Mosholu Parkway North since October 2008.
 - 2) He expressed concerned about oversight of the transitional housing program and residents.
 - C) Leslie Harrison Bronx Library Center:
 - 1) He is asking for continued support for library activities as they face serious cut-backs in the upcoming months. The main branch may lose 7 day service.
 - D) Ricardo Martinez Community Resident:
 - 1) Spoke about the proposed shelter near P.S.8 on Mosholu Parkway and his concerns about the safety of the children and the community-at-large. Inquired as to what the board will be doing about it and what response was given to the Dept. of Homeless Services.
 - E) Stacy Heaver representing Congressman Serrano's Pickens Plan:
 - 1) Talked about energy policy and its effects on children's health when controls are not in place
 - F) Lilly Jones Saint Nicholas of Tolentine:
 - 1) Parish to address issues that need the attention of public officials, the greatest being traffic safety. The group has gathered a petition protesting overall traffic conditions
 - G) Dave Laguer CERT Team & Youth Cadet Program:
 - 1) Discussed the function of the CERT Team and expressed the need for new members to become part of the group. The next training begins on March 2nd, and will last for 11 weeks
 - H) Lissette Casanova P.S. 8 Volunteer:
 - 1) Expressed concerns about the proposed homeless shelter across from the school. She is seeking guidance and advice on how to prevent this from happening

 - C) January 20th Minutes were unanimously approved
