### GENERAL COMMUNITY BOARD MEETING MINUTES TUESDAY, JUNE 21<sup>st</sup>, 2011 Meeting held at: Botanical Garden & Bronx, New York 10458

- I) Public Session opened up at 6:40pm
- II) Paul thanked the Botanical Garden for their hospitality at tonight's meeting and their support throughout the year
- III) Public Session / Speakers:
  - A) Michael Mascetti, Science Schools Initiative:
    - 1) Spoke about the work his agency does to enable youngsters to prepare for entrance into the top high schools in the city
  - B) Aaron Bouska, VP Community Relations for NY Botanical Garden:
    - 1) Introduced himself and shared events that were happening in the Garden. He invited all to com and share in the activities
    - 2) He is requesting support at this time to prevent budget cuts
  - C) Deputy Inspector Dowling, 52<sup>nd</sup> Precinct:
    - 1) Stats were reviewed
    - 2) He reported the increase in burglaries and the need to secure one's residence
    - 3) He noted arrests that were on-going
    - 4) He reported that Grand Larceny along Fordham Road is a problem. Cases involving young people were cited and the need to help teenagers turn their lives around and lead a useful life after one incident
    - 5) Gang activity was discussed and the on-going vigilance by the police is in place

    - 1) Joe announced that "Pop-up" piano program will have 4 places in CB7 for the program
  - F) Ricky Martinez, 100 Democrats Chair:
    - 1) Invites all to the Annual barbecue on Lisbon Place on July 30<sup>th</sup> at 1pm
  - G) Michael Lambert, MPC:
    - 1) Thanked the Board for the partnership between his organization and CB7
  - H) Walter Bell, Board Member:
    - 1) Reported on clean-up activities sponsored by his organization throughout Community Board #7
  - I) Eddie Ramos, Electrician:
    - 1) Thanked the CB for the support of Union Labor for work jobs in the Bronx
  - J) Sefam Aspinal, St. James Parks Residents:
    - 1) She is requesting a dog run in St. James Park. She has a petition to support this request
    - 2) She cited housing issues that are in violation of housing safety and renting rules. Wiring violations are visible. She was referred to the related committees for follow up on the complaints

  - B) He cited the Old Fordham Library and the possibility of developing this site for youth programs

          - ii) 2 voted in opposition of an amendment

        - b) 3 voted in opposition

	Let it be further resolved that any motion brought up by a committee after the Executive Committee has met will be evaluated by the elected board members and recommendation made whether the motion ought to be presented at the general board meeting or sent to the next Executive Committee meeting for discussion.
